#### 23-24 Transition Readiness Grant Application Coming Soon!

The application for the 23-24 Transition Readiness Grant (TRG) Awards will be released on Wednesday March 8, 2023. The application and supporting materials for interested applicants will be posted to the <u>TRG Webpage</u>. School districts and charter schools under <u>Wis. Stat. 118.40</u> (2r) and (2x) are eligible to compete for funding for FY 24 that supports evidence-based practices related to the successful transition from high school for students with IEPs. The \$1.5 million fund will support:

- \* Transportation options (including contracted services or vehicle purchases)
- Competitive Integrated Employment Training (CIE) Programs
- \* Post-secondary tuition/supports for students
- \* Transition Training for Staff Members

#### **Manifestation Determination: IEP Team Considerations**

DPI has received many questions regarding manifestation determinations, so we are sending these reminders with links to more information.

To determine whether a specific conduct is a manifestation of a student's disability, the student's IEP team must review **all** relevant information in the student's file, including but not limited to the student's IEP, any teacher observations, and any additional relevant information provided by the parents.

Additionally, the IEP team must have specific facts related to the conduct leading to the student's potential discipline. Knowing general information about the alleged misconduct without specific information does not provide the IEP team sufficient information to determine if the student's conduct in that specific situation was a manifestation of their disability.

Finally, an administrator cannot direct the IEP team to change the student's placement because of a disciplinary infraction or otherwise influence the IEP team's decision. The requirement to conduct a manifestation determination cannot be circumvented. Any time a student's placement is changed because of a violation of a code of conduct, the student's IEP team must conduct a manifestation determination.

# COVID-19 testing resources for recreational, educational or day camps and early childhood education (ECE) programs

The Wisconsin Department of Health Services (DHS) is announcing the phased step-down of the K-12 COVID-19 School Testing Program, which will affect recreational, educational or day camps and ECE programs. All vendor support will end April 30, 2023.

What does this mean for you?

There will be no vendor support for camps and ECEs. However, DHS is making free COVID-19 antigen test kits available if you wish to set up your own self-test program. *Please note*: **June 15 is the deadline to order these self-tests**. You can obtain them through:

- The DHS Order Website, which allows organizations to order self-test kits online. Instructions on how to order can be found here. Please note that some at-home tests have extended expiration dates, including iHealth and BinaxNOW. For questions about expiration dates, visit this FDA webpage.
- Local and tribal health departments, which have self-tests to distribute to your organization. Find your health department by using this map.

In addition, every Wisconsin household can now get two free at-home COVID-19 self-test kits every month through the <u>Say Yes! COVID</u> <u>Test</u> program. Each test kit includes five rapid antigen tests, for a total of 10 self-tests per order. We recommend promoting this to staff, families, and participants of your programs.

## FDA authorizes first at-home test that can detect both flu and Covid-19

The US Food and Drug Administration authorized what it says is the first at-home test that can tell users if they have the flu and/or Covid-19. The test, made by California biotech company Lucira Health, uses a single self-collected nasal swab and can provide results in about half an hour. The test can be bought without a prescription. It's authorized for anyone 14 and older for self-collection, or an adult can give it to a child 2 or older.

DPI Note: I learned on a STAT call last week that the company Lucira Health has filed for bankruptcy.

## FY 2023 School-Based Service Expansion Funding Opportunity Now Available

HRSA has released the fiscal year (FY) 2023 School-Based Service Expansion (SBSE) notice of funding opportunity (HRSA-23-097). HRSA will make \$25 million available for approximately 70 awards. Award recipients will use this funding to increase access to primary health care services, including mental health services, through new and/or existing



school-based service site(s). If proposing a new school-based service site, the maximum federal funding is \$350,000 per year. If proposing to expand services at existing school-based service site(s) only, the maximum federal funding is \$250,000 per year. Health Center Program operational (H80) grant award recipients are eligible to apply. Health centers must make mental health services available at all school-based service sites where they propose to use SBSE funding. 
## **Practice Points**

We are all emerging even stronger versions of who we were before times. Thank you, Judy, for your kind words at the beginning of this blog post, (yes, I did include them, because you wrote them) but most importantly, for your sweeping definition of what it means to #BeRelentless.

Some thoughts on RELENTLESS SCHOOL NURSES - by Judy Doran

Relentless. – YOU are our A#1 model. Your relentless embodiment is palpable. 0200 or 0600 posts before school. Sometimes night ones when most everybody has shut down. You are ON it.

You also have the capacity to turn on a dime. And shine the conversation on the matter at hand. Your gears are always turning. It's amazing and appreciated! And that is to say you are. Relentless. Fearless. Proud.

So, if we put this on a continuum or spectrum you are as relentless as they come. If we went to the other end of the spectrum, we'd be looking at a person who is defined by the media description of ice packs and bandaids. There might be some like that, but I don't know any.



It is that time of year when school nurses sometimes question what have they accomplished. This blog hopefully will remind each of you that you are relentless school nurses.

#### Who are the others?

The ones who got the water fountain fixed.

The ones who made sure 68 hours of hunger backpacks filled.

The ones who got free eyeglasses.

The ones who organized vaccine clinics.

The ones who made phone calls to providers to square away meds.

The ones who made safe places for a breather.

The ones who taught everybody everything about keeping students with X conditions safe and in school.

The one who tangled with food services for nutritional labels.

The one who pushed for naloxone in school.

The ones who found warm shoes and clothing.

The ones who helped folks navigate loss of housing.

The ones who learned about grieving children.

The ones who step up to learn about gun violence prevention.

The ones who wonder about their physical safety every day.

The ones who stepped up in the face of a worldwide airborne pandemic and proudly declared that while they didn't know much about Covid specifically, they did know infection control and mitigation measures.

The ones who try all day every day to treat children with the dignity they deserve.

The ones who endured outright incivility and abuse from adults and kept going.

The ones who speak in front of the school board.

The ones who write letters.

The ones who exercise their voice.

The ones who with their eyes open, assume responsibility for the health and safety of hundreds or thousands of other people's children 180 ish days per year.

Honestly, the ones who show up every day.

Probably a year or two into school nursing I came to the realization that nothing and everything preceding had prepared me to be a school nurse. How do you even explain it? Even to other nurses. It is indeed a very broad specialty. It's like can you simultaneously practice/balance ten thousand different things (few of which are actually clinical)? Then at the same time you need to be on your clinical game because weird and scary stuff can and does happen. OK, then you can be a school nurse. To be a good one, you need to be relentless which I'm going to argue most are in their unique ways. That's why when you meet a kindred one, you can immediately share a laugh, an "I know EXACTLY what you mean!" moment. You know a lot about each other before the introductions are even done. I'm proud to have been a school nurse. Think I'm closing out pretty soon and I will always say I have had the privilege of being a nurse.


