Greetings!

Last week I shared information with school nurses regarding the Center for Disease Control and Prevention's (CDC) Public Health Workforce Grant awarded to the state public health agencies, including our Wisconsin Department of Health Services (DHS). DHS received approximately \$35 million with \$8.7 million targeted to school health services. Please read Practice Points which further describes the grant funding. The Department of Public Instruction's involvement has been to offer suggestions on use of the funding and implementation measures. The Cooperative Educational Service Areas (CESA) are the distributing the funding for DHS. Each CESA is determining how best to communicate with school district administrators regarding this funding.

I highly recommend watching the recordings of two webinars I viewed last week. One was the Asthma & Allergy Network's webinar discussing food allergies from different developmental levels (p.7). The other was the Our Choice Prevention Education Webinar Vaping and Marijuana- Drug Trends For Teens In 2022 (p.10).

During the food allergy presentation, it was mentioned **that sending out list of "safe snacks" can be misleading.** So, while I urge caution, I also note this highly used resource that indicates the lists are reviewed and updated regularly SnackSafely.com

As was discussed on the DHS/DPI webinar this week, COVID is not "over." This update contains information regarding **new variants**, **possible fall COVID scenarios**, and information **on getting free at home test kits and child-size masks** from DHS.

2021 Youth Risk Behavior Survey (YRBS) Statewide Sample Data Available

DPI is pleased to release its 2021 Statewide YRBS Data on the YRBS webpage. Some documents posted include overall summary tables and graphs for all variables, trend reports, an Academic Achievement Report, and the Sexual Identity Report. The Centers for Disease Control produced each document in partnership with DPI, and a statewide summary report based on this data is forthcoming.

Notably, DPI has identified continued high rates of mental health issues, with 52.2 percent of students self-reporting problems with anxiety and 33.7 percent of students self-reporting problems with depression. Suicidal ideation remains high, with 18.1 percent of students reporting that they seriously considered attempting suicide in the 12 months prior to the survey. Beyond this, rates remain unchanged across nearly all Alcohol and Other Drug Abuse (AODA)/tobacco prevalence questions. Finally, DPI has continued to identify students of color, females, and lesbian, gay, bisexual, and transgender (LGBT) students generally reporting fewer supports and more challenges.

The YRBS was administered in the Fall of 2021. Fifty high schools were selected for the State of Wisconsin sample. Of those schools, 43 chose to participate, and 1,838 students took the survey. These schools were vital in ensuring Wisconsin had a statistically sound, representative sample for the YRBS data collection.

2022-2023 Wisconsin School Health Program Award and Coaching

We are excited to announce that in 2022, the <u>Wisconsin School Health Award</u> will evolve! This evolution will include a continuation of the Wisconsin School Health Award Program and an addition of the Coaching Program. This coaching opportunity will help schools identify and address health disparities present in their school environment and receive assistance in implementing their action plan.

Both programs (award and coaching) will utilize the <u>Registration Form</u>, <u>Action for Healthy Kids Assessment</u>, <u>DPI Supplemental Questions</u>, and <u>Application</u>. The Award Program will use a portfolio of evidence (attached) and the Coaching Program will use an <u>action plan template</u>. All parts will be due by **12/31/22**.

Schools eligible for coaching will demonstrate the following criteria:

- Completion of registration, assessments, action plan and application.
- Action for Healthy Schools Assessment Score below 85 percent.
- Demonstrated need in two or more areas of the Whole School, Whole Community, Whole Child Model.

Schools eligible for an award will demonstrate the following criteria:

- Completion of registration, assessments, portfolio of evidence, and application.
- Action for Healthy Schools Assessment Score above 85 percent.
- Demonstrated success in eight or more components of the Whole School, Whole Community, Whole Child Model.

State Health Department Introduces New Flu Vaccine Data Dashboard and Report on Vaccine Coverage in Wisconsin

The Wisconsin Department of Health Services (DHS) released its Influenza Vaccine Update and launched a new online flu vaccine data dashboard. Together, the report and data dashboard provide a look at previous and current flu vaccine rates statewide and highlight communities and areas of the state more vulnerable to the seasonal flu.

Free Fentanyl Test Strips Now Available Statewide

The Wisconsin Department of Health Services (DHS) today announced that 120,600 fentanyl test strips have been distributed to organizations across the state to help prevent drug overdose deaths. Drugs mixed with <u>fentanyl</u> are the leading cause of overdose deaths in Wisconsin.

"Wisconsinites who use drugs are more likely to encounter fentanyl than ever before," said DHS Secretary-designee Karen Timberlake. "Tragically, many people who use drugs have no idea they are ingesting fentanyl until it's too late. That's why we need to empower our family members, friends, and neighbors who use drugs to have as much information as possible to protect their safety. Fentanyl test strips are a critical tool in our efforts to save lives." View the entire news-release.

State Agencies Launch Real Talks Campaign to Prevent and Reduce Substance Use

In response to rising rates of substance use across Wisconsin, Gov. Tony Evers, the Department of Health Services (DHS) and Department of Justice (DOJ) have unveiled Real Talks Wisconsin, an effort to give residents the information they need to keep themselves, their families, and their communities healthy and safe.

Real Talks Wisconsin promotes frequent conversations to prevent and reduce substance use through supportive relationships. Real talks are based on asking open-ended questions, having empathy, and helping problem solve. View the entire news release.

Districts/Schools Can Place Additional At-home Test Orders

Districts/schools are now able to place additional orders of at-home COVID-19 antigen tests through the DHS website. Schools/districts were first able to order at-home antigen tests for distribution in August.

These tests are intended for K-12 schools to distribute to students and staff. At-home test orders should not exceed the population of students and staff for each district/school. Schools/districts do NOT have to be enrolled in the K-12 COVID-19 Testing Program to order at-home antigen tests. Updated guidance from DHS allows at-home tests to be used in certain public health decisions, including "determining if someone has COVID-19 for the purposes of returning to work or school." A confirmatory PCR test may be required in certain scenarios.



Schools are still able to order child-size KN95 masks for children aged 2-12 from the Wisconsin PPE stockpile. Schools are also temporarily able to request adult face masks and vinyl gloves.

School districts may continue to submit requests via the DHS Stockpile Request form. The child-size masks should only be provided in response to requests and not for general distribution, and the quantity requested should not exceed enrollment of children at each facility. 

Families and Caregivers





Unprecedented

At the time I am writing this, the "official" announcement from Governor's Evers office regarding the \$8.7 million public health workforce grant money directed to school nurses and school health services has yet to be released. This public health workforce grant funding is a one-time funding source, yet the amount and scope is unprecedented for Wisconsin school nurses. The amount awarded to individual school districts will be publicly available once the official announcement is made.



In the Spring of 2021 as part of the American Rescue Plan state public health departments received money from the Centers for Disease Control and Prevention (CDC) to "expand, train, and sustain a response-ready public health workforce." The CDC stated that it "expected at least 25 percent of the money would support school-based health programs including school nurses or other school-based health services personnel." The money is intended to provide for "hiring school-based nurses, converting current nurses from part-time to full-time work, increasing hours, increasing nursing salaries or otherwise supporting retention efforts." Wisconsin's Department of Health Services (DHS) received approximately \$35 million with \$8.7 million targeted to school health services. The funding currently goes through June 30, 2023.

Since the Summer of 2021 DHS has been working on how to implement the grant and spend the money. The Department of Public Instruction (DPI) has offered suggestions on both. The fiscal agent for these funds are the twelve Cooperative Educational Service Areas (CESA). Each CESA has agreed to help distribute funds to school districts which use the money in accordance with the parameters DHS has set. The funds are available to every local public school, tribal school, and non-public school in Wisconsin to support school health services.

DHS used an intricate formula to determine how much money each school districts will receive. It is based on social vulnerabilities, current school nurse FTEs and number of students, geographic location (USDA rural rating), number of students with disabilities, among other factors. Every school (district) will receive some money. The total amount is based on the DHS formula.



Funds from this grant will address the staffing needs, qualification development, membership attainment, and mental health resources to ensure school nurses in Wisconsin are equipped and supported in serving the children of Wisconsin.

The CESAs are paid to administer the funds. Districts should be hearing from the CESAs regarding these funds as your district must opt in to receive them. If your district does not opt in the money will be redistributed to other school districts. Some CESAs may have timelines for opting in.

There are two primary "strategies" or uses for the money. Strategy 1 is for recruitment and retention of school health staff to include school nurses, aides, and other school health support staff. Strategy 2 is for wellness, training, and memberships. This is where the money for every school nurse to have their Wisconsin Association of School Nurses/National Association of School Nurses (WASN/NASN) membership dues paid fits. Your district must opt in for the money for you to receive a free WASN/NASN membership for a year.

District administrators will be working with CESAs on how best to utilize the one-time grant funding. Use of the funding may look different among Wisconsin school districts. While an administrative decision, I hope district school nurses are asked to provide input. Approximately \$7.6 million is directed to the recruitment and retention of school health staff. Staff positions hired before July 1, 2022 are not refundable. The DHS has told CESAs allowable activities include:

Hiring full time nurses for 1 year (2022-2023), including:

- ☐ Hiring full time RNs to perform the duties of a school nurse
 - Full time RN devoted to managing COVID-19 related needs for the school and/or district
 - Full time District Lead RN devoted to supervising school nursing staff, managing COVID-19 efforts and building strong school nursing
 - · infrastructure focused on retaining school nursing staff
- ☐ Increasing part-time school nurse positions to full-time positions for one year (2022-23), including:
 - Conversion of part time positions to full time positions
- ☐ Supporting recruitment efforts for school nurses, including:
 - Administrative staff, including human resources personnel; staff to track and report on to ensure rapid hiring and procurement of goods and services.
- Supporting retention of school nurses, including:
 - Retention bonuses
 - Schools must follow their documented policies for bonuses.
 - Registration for the WASN conference could be included as a retention strategy according to DHS.

Wellness activities are limited to fulltime (37 hours or more per week) RNs and LPNs. Interestingly, some of the activities DHS has listed here include:

- State and National Park passes
- Gym Memberships
- Fitness classes (virtual/in-person)
- Yoga classes (virtual/in-person)
- Physiotherapy and chiropractors

Any RN or LPN working in schools regardless of FTE status will be reimbursed for one year extension of their WASN/NASN membership, or to join for the first time. RNs can be active or associate members, while LPNs are automatically assigned associate membership in WASN/NASN. Associate members cannot vote or hold office but have access to all NASN professional development and national and state discussion lists. Make sure your district has opted in to work with your CESA and receive the grant money. Then apply to become a member of WASN/NASN by clicking here (your WASN "district" is the same as your CESA district.) The district can then complete forms with your CESA to get that membership fee reimbursed.



If you are already a member and your membership expires before June 2023 you can get reimbursed at the time you renew. If you already renewed your WASN/NASN membership between July 1 and now, you can seek reimbursement. Make sure your district pays for your membership if joining or renewing as they will get the money from the CESA not you personally.

Payment for some professional development or training is also included in this grant. Since some of the NASN training courses are free to NASN members and since all school nurses can now be NASN members, school nurses can get a financial "incentive" for completing NASN training. Two trainings mentioned include NASN's health equity training (\$80) and NASN's Narcan Training (\$50). I am working with DHS to find the links to this NASN training, so it is easily accessible. School nurses may have the fee for the WI Prevent Blindness vision screening training reimbursed (\$90). All trainings must be completed between July 1, 2022 and June 30, 2023.

This public health workforce grant funding is a one-time funding source. It is the first time in my three-decade career that money has been directed to ensure all school nurses in Wisconsin are equipped and supported in meeting the health needs of Wisconsin school children and adolescents. The School Nursing Standards of Practice of Education (13), Quality of Practice (15), and Resource Stewardship (17) are imbedded in this opportunity. I encourage school nurses to work with their district administration as more is shared and plans to utilize the money are made.
