

## **February 2012 Delivery Delays, Updates and Cancellations**

**Update:** 100046, whole liquid eggs (A568) – DPI received more of the whole liquid eggs for the State of Wisconsin. Therefore, the February 2012 orders will include the October 2011 back-order amounts (in addition to the amounts originally requested for February 2012). No adjustments can be made to the amounts originally requested for October 2011 or February 2012 delivery.

**Update:** 100125, turkey roasts (A537) – DPI received the back-order shipment of turkey roasts. Therefore, the February 2012 orders will include the January 2012 back-order amounts (in addition to the amounts originally requested for February 2012). No adjustments can be made to the amounts originally requested for January 2012 or February 2012.

**Update:** 100158, ground beef (A608) – DPI received the back-order shipment of ground beef. Therefore, the February 2012 orders will include the January 2012 back-order amounts (in addition to the amounts originally requested for February 2012). No adjustments can be made to the amounts originally requested for January 2012 or February 2012.

**Update:** 100212, mixed fruit (A470) – DPI received the back-order shipments of mixed fruit. Therefore, the February 2012 orders will include the December 2011 and January 2012 back-order amounts (in addition to the amounts originally requested for February 2012). No adjustments can be made to the amounts originally requested for December 2011, January 2012 or February 2012.

**Update:** 100220, diced peaches (A409) – DPI received the back-order shipment of diced peaches. Therefore, the February 2012 orders will include the January 2012 back-order amounts (in addition to the amounts originally requested for February 2012). No adjustments can be made to the amounts originally requested for January 2012 or February 2012.

**Cancellation:** 100313, canned corn (A110) – Due to crop shortages, USDA has cancelled several trucks of canned corn for the state of Wisconsin. Therefore, all remaining orders of canned corn for February 2012 and beyond have been cancelled in the Wisconsin USDA Foods Ordering System. Therefore, please access the “Survey” tab in Program Year 2012 of the Wisconsin USDA Foods Ordering System to view these adjustments.

**Cancellation:** 100330, canned salsa (A237) – Due to crop shortages, USDA has cancelled several trucks of canned salsa for the state of Wisconsin. Schools will receive orders in full for February 2012 and March 2012. However, only **some orders for April 2012** and **no orders for May 2012** will be received. These adjustments have been made in the Wisconsin USDA Foods Ordering System. Therefore, please access the “Survey” tab in Program Year 2012 of the Wisconsin USDA Foods Ordering System to view these adjustments.

**Delay:** 100351, frozen green beans (A070) – Due to a delay at the vendor, DPI only received a partial shipment of frozen green beans. Therefore, schools serviced out of VersaCold Logistic Services, **only**, may receive none or less than the amounts originally on order for February 2012. If DPI receives the back-order amounts in time for March 2012 delivery, the March 2012 deliveries will include the back-order amounts (in addition to the amounts originally requested for March 2012 delivery). No adjustments can be made to the amounts originally requested for February 2012 or March 2012 delivery.

**Cancellation:** 100355, potato wedges (A174) - Due to the late harvest of potato crops, there continues to be a delay in shipment of potato orders. Therefore, USDA has made the decision to cancel most of the remaining and back-order amounts of potato wedges. DPI will receive enough potato wedges to fill orders for April 2012 and a portion of the orders for May 2012. All remaining potato wedge orders have been cancelled in the Wisconsin USDA Foods Ordering System. Therefore, please access the "Survey" tab in Program Year 2012 of the Wisconsin USDA Foods Ordering System to view these adjustments.

**Update:** 100358, potato rounds (A204) – DPI received the back-order shipment of potato rounds. Therefore, the February 2012 orders will include the January 2012 back-order amounts (in addition to the amounts originally requested for February 2012). No adjustments can be made to the amounts originally requested for January 2012 or February 2012.

**Update:** 100362, refried beans (A085) – DPI received the back-order shipment of refried beans. Therefore, the February 2012 orders will include the January 2012 back-order amounts (in addition to the amounts originally requested for February 2012). No adjustments can be made to the amounts originally requested for January 2012 or February 2012.

**Update:** 100396, peanut butter (B473) – For schools serviced by Central Storage and Warehouse – Eau Claire, DPI received the back-order shipment of peanut butter. Therefore, the February 2012 orders will include the January 2012 back-order amounts (in addition to the amounts originally requested for February 2012). No adjustments can be made to the amounts originally requested for January 2012 or February 2012.

**Update:** 100500, brown rice (B537) – DPI received the back-order shipment of brown rice. Therefore, the February 2012 orders will include the January 2012 back-order amounts (in addition to the amounts originally requested for February 2012). No adjustments can be made to the amounts originally requested for January 2012 or February 2012.

**Update:** 110080, oven-roasted chicken (A494) – USDA was able to purchase some of the oven-roasted chicken orders for the State of Wisconsin. Therefore, schools will receive the January 2012 back-order amounts in February 2012 (in addition to the amounts originally requested for February 2012). However, the October 2011 and December 2011 amounts will remain on back-order. If the back-order amounts arrive in time for March 2012 delivery, DPI will fill the October 2011 and December 2011. No adjustments can be made to the amounts originally requested for October 2011, December 2011, January 2012 or February 2012 delivery.

**Update: C305,** turkey deli breast – DPI received the back-order shipment of turkey deli breast. Therefore, the February 2012 orders will include the January 2012 back-order amounts (in addition to the amounts originally requested for February 2012). No adjustments can be made to the amounts originally requested for January 2012 or February 2012.
