Fall Re-Interviewing

Every three years, we are required by law to assess the reliability of our records by hiring a third party consultant to re-interview a random selection of previously certified migrant children. Re-interviewing will take place at the end of September and the beginning of October. The consultant will be accompanied by a Migrant Education Program (MEP) staff member. We will notify the districts that have families to be re-interviewed. We will contact local MEP staff if we need assistance in locating families.



Regular Year Allocations
