Forward Exam Update



OEA would like to thank all educators who participated in the Forward Exam New Item Review that took place this summer. Educators from all around the state reviewed and provided critical input

on newly developed Forward Exam test questions for future use. We encourage you to apply to participate in the following 2024 educator involvement opportunities:

- Rangefinding (spring 2024) Wisconsin educators will review and approve scoring guides, select anchor, training, and qualifying papers used by evaluators to score the Forward Exam short write tasks.
- Standard Setting (spring 2024) Wisconsin educators will recommend cut scores for the Forward Exam in English Language Arts (ELA) and Mathematics. The cut scores separate students into four achievement levels, which provide clear indicators of a student's level in relation to the Wisconsin Academic Standards and indicate if they are on track for future learning.
- Item Review (summer 2024) Wisconsin educators review all new test questions created for the exam for content, grade level appropriateness, alignment to correct standard, cultural inclusivity, and bias/sensitivity issues prior to placement on the exam.

Individual Student Reports (ISRs) were delivered to districts over the summer. If you have not yet sent ISRs to parents/guardians (either in hard copy or via your secure parent portal), please send those out as soon as possible.

The 2023-24 Accessibility Guide is now available on the <u>Forward Exam Accommodations and Supports</u> <u>webpage</u>. There have been some significant updates to the Accessibility Guide for 2023-24 which include

Text-to-Speech (TTS), Stacked Translation (Spanish), Closed Caption, Listening Script, and Magnifier Tool. There have also been some minor updates throughout the guide. Please review the updated Accessibility Guide thoroughly prior to the 2024 test administration.

The spring 2024 Forward Exam for ELA and Mathematics at grades 3-8 will be aligned to the new Wisconsin Standards for ELA (adopted in 2020) and Mathematics (adopted in 2021). There have been some changes to the ELA test design. These changes include:

- Three ELA test sessions instead of four. The test sessions will be:
 - Session 1 Reading Comprehension
 - Session 2 Language Arts/Writing
 - Session 3 Language Arts/Writing
- The listening session has been removed.
- The Text Dependent Analysis (TDA) has been removed and replaced with two one-paragraph, mode specific, writing tasks in test sessions 2 and 3, in addition to the language arts and writing questions.

Updated Forward Exam Practice Tests will be available in December on the <u>Forward Exam</u> <u>Practice Tests webpage</u> to help students prepare. More information about the newly aligned assessments will be communicated over the next several months.

The ACT with writing Update

© 2022-23 ACT and PreACT Secure reports were provided to school districts in late spring. Reports are still available in PAnext and in the ACT Online Reporting Platform (Success).

Eleventh grade students will be administered the ACT® with writing in spring 2024. Dates for the spring 2024 ACT assessment can be found on the ACT Calendar webpage. As in previous years, districts will have the choice to administer the ACT on paper or online. Online ACT testing allows districts more administration flexibility, including additional testing dates. Over 50% of students tested online this past year.

Schools are able to start requesting student accommodations and English learner supports for the 2024 ACT now. The 2024 ACT Accessibility Supports Guide and additional accommodation resources can be found on the DPI ACT
Accommodations and Supports webpage. Additional required tasks for ACT will begin in early November, with PearsonAccess
(PAnext) opening on November 6. Questions about The ACT may be directed to Nikki Braconier.

PreACT Secure Update



Students in grades 9 and 10 will be required to complete the PreACT Secure (online)

assessment in the spring. Dates for the PreACT Secure testing can be found on the <u>PreACT Secure Calendar webpage</u>.

The 2024 PreACT Secure Accessibility Supports Guide will be posted to the <u>DPI PreACT Secure</u> Accommodations and Supports webpage in November. Schools will begin entering accommodations into the PreACT Secure online portal once the portal opens for 2024 testing. Questions about PreACT Secure may be directed to Nikki Braconier.



Dynamic Learning Maps (DLM) Update



Dynamic Learning Maps (DLM) is the statewide assessment for the most

significantly cognitively disabled students in grades 3-11. In addition to the annual assessment, DLM also provides an Instruction and Assessment Planner to help educators monitor student progress on targeted Essential Elements. The Planner is used to help guide instruction and can be used as an alternate to district wide interim or benchmark testing. We encourage interested educators to check out this valuable resource.

During the first part of the school year, districts and schools should be rostering (uploading) their students and updating their users in KITE Educator Portal. Completing these tasks early allows educators adequate time to begin their required annual DLM training, submit test security agreements, finish first contact surveys, and access the Instruction and Assessment Planner.

2022-23 DLM student and summary reports were released to districts via the KITE Educator Portal in July.

ACCESS for ELLs® Update



This year WIDA will begin using the newly updated Alternate ACCESS for ELLs. If you will be

administering the Alt-ACCESS to students, please note the training has been updated.

WIDA has refreshed its <u>on-demand eLearning</u> <u>courses</u> provided in the WIDA Secure Portal. These professional learning courses run from two to 10 hours and are free to any educator in the state of Wisconsin. If staff in your district need professional development, please create accounts as needed.

Students who have exited English learner (EL) status should retain "ELP 6 - Former EL" as a designation for the remainder of their school careers. If students are later reported as "ELP 7 - Never EL", the WISEdata Portal will now flag this with a warning. In conjunction with future WISEdash for Districts filter upgrades, this better tracking of Former ELs will allow for an analysis of their long-term outcomes, such as performance on the ACT, graduation rates, etc. We hope that this will expand the ways districts can look at the effectiveness of their language instruction programs, to ensure the long-term success of their ELs.

Assessment of Reading Readiness Update



For the 2023-24 school year, the requirement remains to annually assess each 4-year-old kindergarten to 2nd grade student in a school district or in a

charter school for Reading Readiness. Wis. Stats. 118.016 requires each school board and the operator of each charter school to select the appropriate, valid, and reliable assessment of literacy fundamentals to be used. The school board or operator shall ensure that the assessment evaluates whether a pupil possesses phonemic awareness and letter sound knowledge.

In addition to the requirement to administer a literacy screener, the following conditions apply:

- The department shall pay to the school board or operator the per pupil cost of the selected assessment.
- The school board or operator of the charter school shall report the results of a pupil's assessment to the pupil's parent or guardian.
- The school board of the school district or operator of the charter school in which the pupil is enrolled shall provide a pupil whose assessment indicates that he or she is at risk of reading difficulty with interventions or remedial reading services, as described under <u>Wis. Stats.</u> 121.02(1)(c).

Districts that wish to share MAP screening data with DPI will need to complete the <u>Local Assessment</u> <u>Data Use Agreement</u>. Completion of this process will allow the MAP vendor to automatically share data with DPI for use with WISEdash For Districts.

State Accountability Updates



OEA staff are preparing for the preliminary secure release of 2022-23 school and district report cards. The secure release of preliminary report

cards is planned for early October. As always, preliminary secure report cards will be available in SAFE, the Secure Access File Exchange. Please make sure you have <u>access to SAFE</u> prior to the secure release.

The release will open an inquiry period in which schools and districts can work with OEA to address possible data submission errors. Final secure and public releases of the report cards are planned for November. When specific dates have been determined, we will update the report card timeline and announce it in the DAC Digest.

Federal Accountability Updates



The Every Student Succeeds Act (ESSA) requires the Wisconsin Department of Public Instruction (DPI) to identify schools and student

groups for support and improvement. Beginning in the 2023-24 school year, the Every Student Succeeds Act (ESSA) and Individuals with Disabilities Education Act (IDEA) reports will be available in February and April as part of the Joint Federal Notification (JFN) packet. Update Regarding the Assessment Analysis Dashboard in WISEdash for Districts



The Assessment Analysis dashboard is now available in WISEdash for Districts. This dashboard allows schools and districts to explore assessment performance information

that is used in state and federal accountability systems (state school and district report cards and federal Every Student Succeeds Act (ESSA) accountability). It shows how many students are in each Wisconsin Student Assessment System (WSAS) performance level for a given school year, across grades and assessments. The new dashboard is found in the Advanced Analysis area of WISEdash for Districts under Assessment Analysis. For more information about this dashboard, please see the About the Data page. Please note that this dashboard is only available securely to school and district staff with access.

If the school is administering the ACT on paper only, then make-up testing should be scheduled for the next available ACT paper test date (i.e., March 28 or April 9). Schools may also opt to administer online make-up tests to the students originally scheduled for paper testing. All online testing, scheduled or make-up, must be administered during the scheduled online ACT testing windows.
