- ☑ Other, please describe: The De Soto Area School District maintains collaborative efforts with the Vernon County Health Department to offer fall flu and COVID-19 vaccination clinics to students and staff aligned to the CDC's information that vaccinations remain the #1 preventative measure. The District's plan outlines the CDC School Guidance updated August 11, 2022; the continuation of school based rapid antigen testing programs for students and staff; layered mitigation and prevention; health and wellness protocols; support services; academic options; and resources. The plan includes information on mitigation and preventing the spread efforts through masking, hand washing and face coverings, respiratory etiquette, cleaning and disinfecting, ventilation, isolation for COVID-19 positives, staying home when sick, instructional options if positive, continuation of services (IEPs, 504s, food service and SEL). The District also provides a COVID-19 & School Updates resource webpage with information going back to Feb. 2020.
