Dear Educators,

The Office of Student Assessment has received concerns regarding limited testing availability for the July 18 National ACT testing. We have been working diligently with ACT to find viable options for students to test and have received notification that ACT has extended the deadline for sites to register as National testing centers for July. If you are not currently registered to administer the ACT in July and are interested in participating, please see registration options and deadlines below.

**Current or Prior National ACT Test Center:**

Please contact ACT at 800.553.6244 ext. 1510 as soon as possible, but not later than **June 19**. You will need to have the following information ready:

- Reporting Location- Name of test center, address, test coordinator contact information
- ACT Testing Code
- Capacity for July test date

**New National Test Center:**

Please contact ACT at 800.553.6244 ext. 1510 **immediately**.

Reminder: As a public open testing site, your site will be posted to the ACT website and will be first come, first served registration. Your school and ACT will not be able to prioritize registration (e.g. untested 11<sup>th</sup> grade students with vouchers).

**Unlisted Test Center:**

As an unlisted test center, your site would receive a private ACT test center code and not be publicized on ACT's website. Only students with the private test center code could register for your testing site (e.g. untested 11<sup>th</sup> grade students with vouchers or other students from your school/district). Sites would be responsible for providing this code to your students before registration.
