Subject: WI Statewide ACT Assessment Update - July 27, 2020 - Fall Voucher Testing

Dear Educators,

In response to the limited voucher testing availability of the July 18 National testing date, the Department of Public Instruction (DPI) is providing additional voucher testing opportunities for ACT with writing for any students who were in the 11th grade in Spring 2020 who were not able to participate in the 2020 statewide ACT administration due to school closures caused by the COVID-19 pandemic. These vouchers allow students who were unable to test the opportunity to take the ACT with writing during the following fall National testing dates:

- Saturday, September 12
- Sunday, September 13
- Saturday, September 19
- Saturday, October 10
- Saturday, October 17
- Saturday, October 24
- Sunday, October 25
- Saturday, December 12

During the week of August 3, District Assessment Coordinators (DACs) will receive an email directly from ACT containing detailed information about the voucher program that includes:

1. Instructions on how to disseminate the vouchers to schools/students.
2. An electronic file containing individualized serial vouchers.
3. Detailed instructions on how students register for ACT National testing with a voucher.

Upon receipt of your district's vouchers, please review the instructions and supporting documentation carefully to determine the best approach to disseminating vouchers within your district. School staff may choose to distribute vouchers in the form of hard or electronic copies. ***If you do not receive your vouchers from ACT by August 7, please contact: [Nikki Braconier](#).***

Important Voucher Information:

- DPI provided vouchers are intended solely for students who were in the 11th grade in Spring 2020 who were scheduled to participate in the Spring 2020 ACT with writing statewide administration, but were unable to test due to school closures. These vouchers provide students with the opportunity to test. **There is no requirement that students test. Please reach out to eligible students first to determine their interest prior to sending a voucher.**
- Limit one voucher per student
- Students who registered for the July 18, 2020 National testing date with a DPI voucher are not eligible for an additional voucher
