New:

Updated Performance Levels for Statewide Assessments

Associate Deputy State Superintendent Tom McCarthy sent an [email to District Administrators](#) on June 5 to announce that DPI is updating terminology used to describe student performance levels on statewide standardized assessments. The terms developing, approaching, meeting, and advanced will replace the previous, outdated terms. These updated performance levels will be used to report the Forward Exam, ACT, and PreACT Secure assessment data and results beginning with the 2023-24 administration. The DPI received overwhelming support for this change from Wisconsin educators, administrators, parents, families, and education partners in a survey. DAC Contact Updates During the Summer and into the 2024-25 School Year

It is important to keep your District Assessment Coordinator (DAC) contact information up to date over the summer months and as staffing changes occur from 2023-24 to 2024-25. Communications from OEA will be sent to DACs over the summer and into early fall regarding assessment and accountability, including information on data and reporting availability. You may need to assign an Interim DAC to ensure your district continues to receive updates while filling the DAC position for the 2024-25 school year. The DAC contact information is used to verify who should have DAC level access to reports in the vendor portals. Be sure to complete a [DAC Update form](#) with the appropriate effective date noted if any changes are needed for the coming months.

The 2024-25 annual [District Assessment Coordinator \(DAC\) and Technology Coordinator \(DTC\) contact update forms](#) may be submitted by all districts beginning July 1. Please make note of the effective date on



the update form. These forms are required for both new and returning DACs and DTCs, even if the information has not changed. The information provided is used to:

- Ensure DACs receive regular assessment and accountability updates, and
- Upload information into vendor portals to ensure DACs have annual permissions.

DAC and DTC Update forms must be signed by the District Administrator/Superintendent. Districts should also remove permissions in the test vendor portals (or make inactive) from any individuals who are no longer employed by the district and adjust user roles to sync with staffing changes.

PreACT Secure school and district summary reports, student level data files, and all student scores and Individualized Student Reports (ISRs) will be final in ACT's Online reporting System on May 30. Student ISRs

Schools should download and print Individual Student Reports (ISRs) and distribute them to students and families after May 30. Please reference the [May 28 ACT Program Email](#) for instructions on how to download and additional resources.

The DLM Individual Student Reports (ISRs) and summary reports will be electronically available to districts in the Educator Portal on June 21. Be sure to provide parents/guardians with ISRs as soon as possible after electronic receipt.

Forward Exam Educator Involvement Opportunities 2024

OEA would like to thank the educators, from all over Wisconsin, who participated in the Forward Exam Rangelinding this spring. Their incredible work finalizing the short write rubrics, approving scoring guides, and selecting anchor, training, and threshold papers is what DRC staff are using to score the new Forward Exam ELA short write tasks.

We would also like to thank everyone who applied to participate in the Forward Exam Standard Setting and New Item Review that will take place this summer. These events are great opportunities for educators to participate in the development and scoring of the Forward Exam. Educators selected to participate in Standard Setting have already been notified, and those selected to participate in New Item Review should have begun to receive email notifications which will continue to go out until the end of the

school year. Those not able to apply or participate this year will have the opportunity to apply for the summer of 2025 review. New Item Review application information is posted every year in early spring on the [Forward Exam Educator Involvement webpage](#).

Translated Individual Student Report (ISR) Templates

Districts are responsible for the secure distribution of the ISRs to parents/guardians in a language they can understand and in a format that is accessible to them. Districts and schools may include a copy of the Spanish or Hmong translated ISR with the English ISR, so families have a better understanding of their student's results. If translated sample ISRs are needed in languages other than Spanish and Hmong, DACs must contact the [DRC Help Desk](#). Additional ISR translations will be made available as DRC fulfills district requests on the [Forward Exam Data and Results webpage](#). There are currently 11 additional languages already requested by districts which will be available.

Reminder:

Forward Exam Reports

Individual Student Reports (ISRs) and summary reports will be available electronically in the DRC INSIGHT Portal July 26. Hard copy ISRs will be mailed to districts August 27. Be sure to send ISRs out to parents/guardians as soon as possible after receipt either in hard copy or via your secure parent portal.

Districts now have the option to decline the paper ISRs by having their DAC complete and submit the [2024 Forward Exam Request to Decline Paper Individual Student Reports \(ISRs\) Form](#) by June 28. Districts are still required to provide parents/guardians with a complete ISR in either a secure electronic version or paper version. NAEP and International Assessments

(for schools selected to participate in 2023-24 and 2024-25 assessments only)

New:

Notifications for NAEP 2024-25

Emails will go out to District Administrators in mid-June with notification of schools selected to participate in NAEP next school year. DACs will be copied on those emails. Here is an overview of what will be assessed in NAEP 2024-25:

- October 7 - December 13, 2024: Long-Term Trend, age 13, Reading and Mathematics
- January 6 - March 14, 2025: Long-Term Trend, age 9, Reading and Mathematics
- January 27 - March 7, 2025: NAEP Field Test, grades 4, 8, and 12, Reading and Mathematics
- March 17 - May 23, 2025: Long-Term Trend, age 17, Reading and Mathematics

More information about Long-Term Trend assessments can be found on the [DPI OEA NAEP webpage](#) and the [Nation's Report Card webpage](#). The NAEP Field Test will explore the use of school-based equipment

for NAEP testing. District notification will clarify more about these assessments and specify which school is selected for each assessment.

In addition, notification to Principals in schools selected for Long-Term Trend age 13 assessments will be emailed in June. Schools selected for the assessments in other ages/grades will be notified later in the summer or early fall.

NAEP 2024 High School Transcript Study Phase 2

Schools that have been participating in the NAEP High School Transcript Study can begin phase 2 of the data collection on June 3. This phase is the submission of student transcripts. Schools indicated earlier in the study if they will submit transcripts electronically through the [NAEP Assessment Management System \(NAEP AMS\)](#) or through a hard-copy collection.
