Cov tub ntxhais kawm xiam oob qhab thiab cov neeg kawm lus Askiv yuav nkag rau hauv kev ntaus nqi NAEP tau li cas?

NAEP qhov tes dej num yeej ib txwm kam tiag los mus ntaus nqi xyuas txhua tus tub ntxhais kawm uas raug xaiv los ua ib feem ntawm kev lis nws cov qauv. Nyob hauv txhua lub tsev kawm hauv NAEP, yuav muaj kev pab ua ke yooj yim rau cov tub ntxhais kawm muaj kev xiam oob qhab (SD) thiab/los sis cov neeg kawm lus Askiv (EL).

Kev rub cov tub ntxhais kawm SD los sis EL nkag rau NAEP yog ib qho uas raug txhawb nqa yog tias tus tub ntxhais kawm ntawv (a) nkag koom nrog kev ntaus nqi kev kawm hauv lub lav xwm yeem nyob rau xyuam kawm uas yuav raug ntaus nqi, thiab (b) yog tias tus tub ntxhais kawm ntawv tuaj yeem koom rau NAEP nrog cov kev pab ua kev yooj yim uas NAEP tso cai. Feem ntau, cov kev pab ua kev yooj yim

ntawm NAEP yog zoo ib yam los sis thooj ib yam li cov kev pab ua kev yooj yim ua tau muaj ntawm kev ntaus nqi xyuas ntawm lub lav.

NAEP yog dab tsi?

National Assessment of Educational Progress (NAEP) yog cov neeg sawv cev uas coob tshaj plaws hauv thoob teb chaws thiab ntaus nqi xyuas ua ntu zus txog yam uas Asmeskas cov tub ntxhais kawm paub thiab tuaj yeem tau nyob rau txhua xyuam kev kawm. Tau txais kev txhawb nqa los ntawm Asmeskas Lub Tsev Hauj Lwm Saib Xyuas Kev Kawm Ntawv, NAEP cov kev ntaus nqi tau ua txhua xyoo nyob hauv kev nyeem ntawv thiab kev ua lej, nrog rau lwm cov xyuam kawm uas tau xeeb txhua xyoo xws li txuj ci tshawb fawb qhov tseeb, kev sau ntawv, keeb kwm ntawm Asmeskas, kev kawm txog txoj cai rau zej tsoom, kev kawm txog huab cua teb chaws, kev txawj rau fab tev naus laus zis thiab kev txuj ci ua vaj ua tsev, txuj ci kev ua yeeb yam, thiab lwm xyuam kev kawm, pib thaum xyoo 1969. NAEP sau cia thiab tshaj qhia txog cov txiaj ntsig kev kawm txuj ci nyob rau qib teb chaws, thiab rau qee qhov kev ntaus nqi, nyob rau qib lav thiab cheeb tsam.

Txhawm rau saib seb cov xyuam kawm thiab cov qib kawm twg yog cov raug ntaus nqi txhua xyoo, saib NAEP Cov Kev Teem Tseg txog Kev Ntsuam Xyuas ntawm <https://nces.ed.gov/nationsreportcard/about/calendar.aspx>.

Cov cheeb tsam thiab cov tsev kawm ntawv raug siv ua qauv rau NAEP cov kev ntaus nqi txhua xyoo. Tus Tub Leg Hauj Lwm Hauv Lub Lav ntawm NAEP nyob hauv Wisconsin ceeb toom cov cheeb tsam thiab cov tsev kawm uas lawv xaiv los koom nyob rau thaum pib lub xyoo kawm. Thaum cov tub ntxhais kawm raug xaiv los koom, tsev kawm ntawv yuav tsum ceeb toom rau cov niam txiv txog qhov kev los koom ntawv; qhov no feem ntau ua nyob rau Lub Kaum Ob Hlis Ntuj los sis Lub Ib Hlis Ntuj.

Cov qhab nias NAEP uas xeeb tau los yuav raug siv li cas?

Txij li cov kev ntaus nqi NAEP raug tswj hwm yam sib xws nkaus nyob thoob plaws teb chaws, NAEP cov qhab nia tau siv los ua qhov kev ntsuas xwm yeem rau txhua lub xeeb thiab cov cheeb tsam nroog loj uas raug xaiv. Txoj kev ntaus nqi xyuas yuav zoo ib yam li qub ib xyoos dhau ib xyoos. Qhov no ua rau NAEP los muab tau tus duab uas pom tseeb ntawm cov tub ntxhais kawm qhov kev nce qib ntawm kev kawm nyob rau txhua lub sij hawm. Txhua tus tub ntxhais kawm cov qhab nias raug siv los tsim ua cov qhab nias ntawm lub lav thiab/los sis ntawm teb chaws (nyob rau ntawm lub xyoo thiab qhov kev xeeb).

NAEP tsim ua Daim Npav Tshaj Qhia Thoob Teb Chaws los qhia rau zej tsoom txog cov kev kawm ua tiav ntawm kev kawm ntawm cov tub ntxhais kawm theem pib thiab theem nrab hauv Teb Chaws Meskas. Qhov kev tshaj qhia no muaj nyob rau ntawm <https://nces.ed.gov/nationsreportcard/>. Cov qhab nias raug tshaj qhia tawm yam dav fo los ntawm cov xov xwm hauv teb chaws thiab hauv lub nroog, thiab yog qhov tseem ceeb ntawm peb lub teb chaws qhov kev ntsuam xyuas cov xwm txheej thiab kev nce qib ntawm kev kawm.

NAEP cov qhab nias tau los ntawm cov neeg sawv cev ua qauv ntawm cov tub ntxhais kawm hauv qib 4, 8, thiab 12 rau kev cov kev ntaus nqi xyuas tseem ceeb, los sis cov qauv ntawm cov tub ntxhais kawm muaj

hnuv nyug 9, 13, los sis 17 xyoo rau kev ntaus nqi ncuva sij hawm ntev.

Yuav tau txais cov hom qhab nias twg?

NAEP **tsis muab** qhab nias rau cov tub ntxhais kawm los sis cov tsev kawm, txawm hais tias NAEP tuaj yeem tshaj tawm cov qhab nia los ntawm cov cheeb tsam nroog loj uas raug xaiv. NAEP **tsis muab** cov qhab nias nyob rau qib lav thiab qib teb chaws.

NAEP muab cov qhab nias ntawm kev ua tiav ntawm cov xyuam kawm, kev qhia kev paub, thiab cheeb tsam puag ncig tsev kawm ntawv rau cov tub ntxhais kawm (xws li, tag nrho qib 4) thiab cov pab pawg nyob rau hauv cov neeg ntawv (xws li, cov ntxhais kawm, cov tub ntxhais kawm haiv neeg Hispanic).

Kuv tuaj yeem nrhiav cov lus nug rau kev xeeb piv txwv los sis xyaum xeeb nyob rau qhov twg?

Cov phau ntawv cov lus nug piv txwv, muaj nyob rau ntawm <https://nces.ed.gov/nationsreportcard/experience/booklets.aspx>, raug tsim muaj rau cov tsev kawm ntawv koom tes yog li ntawd cov neeg tswj xyuas thiab cov xib hwb thiaj paub txog tias yuav tau dab tsi thaum lub sij hawm ntaus nqi xyuas. Cov phau ntawv muaj ntau cov qauv ntawm kev xeeb tiag.

Cov ntaub ntawv puas npog zais tsis pub lwm tus paub?
