#### New:

#### 2022-23 Report Cards Preliminary Secure Release

OEA staff are preparing for the preliminary secure release of 2022-23 school and district report cards. **The secure release of preliminary report cards is planned for early October.** The release will open an inquiry period in which schools and districts can work with OEA to address possible data submission errors. As always, preliminary secure report cards will be available in SAFE, the Secure Access File Exchange. Please make sure you have access to <u>SAFE</u> prior to the secure release.

Final secure and public releases of the report cards are planned for November. More information will be included in next week's Assessment Update. As a reminder, school and district report cards are required annually under <u>state law</u>. If you have questions about report cards, please <u>contact OEA</u>.
