The DPI Community Nutrition Programs will be offering in-person Child and Adult Care Food Program (CACFP) Training this September! Registration is now open.

Training will include a general session and two breakout sessions. Breakout sessions will focus on identifying whole grain-rich, special dietary needs (focusing on dairy allergies and lactose intolerance), financial management, meal planning ideas, and infants.
