New Creditable Non-Dairy Beverages and Updated Creditable Non-Dairy Beverages (Fluid Milk Substitute) Handout (ALL) Two non-dairy beverages have been added to the list of creditable non-dairy beverages. These are Ripple Original Plant-Based Milk in the 32 oz. shelf-stable package and Ripple Chocolate Plant-Based Milk in the 32 oz. shelf-stable package. Note, the 48 oz containers of these products are not creditable non-dairy beverages.

The <u>Creditable Non-Dairy Beverages (Fluid Milk Substitute)</u> handout has been updated.

Updated Creditable and Non-Creditable Cheese Handout (ALL)

The <u>Creditable and Non-Creditable Cheese</u> handout has been updated. This handout provides information on creditable and non-creditable cheeses and amounts of creditable cheese that must be served to credit towards the meat/meat alternate component of the CACFP meal pattern.

REMINDER: Claim Submission Deadlines: Federal regulations impose a claim submission deadline of 60 calendar days after the last day of the month for which the claim applies. For DPI's CACFP Claim Submission Deadlines visit Claim Submission Deadlines.
