Child and Adult Care Food Program Yog Dab Tsi?

Child and Adult Care Food Program (CACFP) yog ib qhov kev pab cuam los ntawm tsoom fww teb chaws uas pab them rau cov nqi zaub mov noj thiab khoom txom ncauj rau cov neeg hauv cov chaw uas tau ntawv pom zoo. CACFP tseem ua kom cov kev pab zoo dua qub thiab kom cov tsev neeg tau nyiaj los tsawg them taus.

Vim li cas ho koom rau hauv CACFP?

Hais tag nrho lus, kev noj qab nyob zoo yog ib feem tseem ceeb ntawm kev muab txoj kev zov kom zoo rau cov me nyuam thiab cov muaj hnuv nyoog. Kev noj zoo rau lub cev thiab kev ua ub no yog ob yam ntawm kev noj qab nyob zoo thiab yog yam txhawb nqa los ntawm CACFP. Los ntawm cov kev pab thiab cov kev kawm, cov chaw thiab cov muab kev pab yuav muaj peev xwm ua kom tej hauj lwm mus los niaj hnuv muaj ntau dua qub, npaj cov zaub mov noj kom muaj zog, thiab ua kom kev noj haus thiab kev ua ub no zoo rau lub cev tag nrho hauv lawv qhov chaw zoo dua qub. Ntxiv mus, CACFP txoj kev koom muaj xws li:

- Muab nyiaj pab ntxiv rau cov nqi yuav zaub mov noj thiab khoom txom ncauj uas zoo rau lub cev.
- Qhia me nyuam thaum ntxov txog txoj kev noj khoom zoo rau lub cev uas yuav kav mus tas lub neej.
- Muab kev noj haus zoo rau cov muaj hnuv nyoog uas yuav pab rau lawv kom lawv pab tau tus kheej mus ntev.
- Muab kev cia siab rau cov niam cov txiv thiab cov pab tu kom paub tias koj tau nqe peev rau txoj kev noj qab nyob zoo ntawm lawv cov me nyuam thiab cov muaj hnuv nyoog hauv lawv tsev neeg.
- Muab tswv yim qhia txog kev npaj zaub mov thiab kev ua zaub mov noj.
- Muab kev cob qhia thiab tswv yim pab rau koj qhov chaw zov kom vam meej nce qib.

Muab hom pluag mov dab tsi rau noj?

Kev koom rau hauv CACFP cov chaw yog muab cov pluag mov muaj txhij txhua uas yog ua raws nraim li cov qaum muab pluag noj ntawm United States Department of Agriculture (USDA). Qhov pluag mov noj muaj dab tsi thiab npaum cas ntawd yog nyob ntawm seb cov neeg koom rau hauv muaj hnuv nyoog li cas.

Cov chaw twg yuav koom tau rau hauv CACFP?

Child Care Centers (CCC)

Cov chaw zov me nyuam muaj ntawv tso cai thiab cov Head Start programs uas muaj pluag mov noj thiab/los yog khoom txom ncauj rau cov mos liab thiab cov hnuv nyoog txog 12 xyoos yuav tau kev pab them nyiaj rov qab txog ob pluag thiab ib pluag khoom txom ncauj los yog ob pluag khoom txom ncauj thiab ib pluag mov tauj ib tug me nyuam, tauj in hnuv.

Family Day Care Homes (FDCH)

Cov chaw zov me nyuam hauv tsev muaj ntawv tso cai muaj cov mos liab thiab/los yog cov hnuv nyoog txog 12 xyoos yuav tau kev pab them nyiaj rov qab txog ob pluag mov thiab ib pluag khoom txom ncauj los yog ob pluag khoom txom ncauj thiab ib pluag mov tauj ib tug me nyuam, tauj ib hnuv.

At-Risk After School Care Programs (AR)

AR programs muab kev ua ub no pab rau cov me nyuam yuav muaj tau teeb meem thiab cov hluas txog hnuv nyoog 18 xyoos. Cov kev ua hauj lwm pab no yuav ua ntawv kom them rov qab cov nqi ntawm cov pluag mov thiab/los yog pluag khoom txom ncauj rau cov me nyuam thiab cov hluas tom qab kawm ntawv los yog cov hnuv tsis muaj kawm ntawv hauv lub xyoo muaj kawm. Yuav kom tau cov nyiaj pab, cov chaw yuav tsum yog nyob rau cheeb tsam muaj tsawg kawg 50 feem pua ntawm cov me nyuam tau txais tsev kawm ntawv cov pluag mov noj tus nqi luv los yog tsis tau them li. Cov muab kev pab rau cov me nyuam 13 txog 18 xyoos xwb yuav tsis tas kom muaj ntawv tso cai raws li Tsoom Fwv Cov Cai Tswj, tshwj tias hauv cheeb tsam los yog lub xeev ho kom muaj no xwb.

Outside of School Hours Care Centers (OSHCC)

OSHCC tau tsim tsa ua ib qho kev pab rau tom qab kawm ntawv (thiab thaum tsev kawm ntawv kaw lawm) rau lub hom phiaj muab kev zov rau cov me nyuam hnuv nyoog 12 xyoos thiab qis dua. OSHCC yuav ua hauj lwm tas xyoo thiab yuav tau txais kev pab them nyiaj rov qab txog ob pluag mov thiab ib pluag khoom txom ncauj los yog ob pluag khoom txom ncauj thiab ib pluag mov tauj ib tug me nyuam, tauj in hnuv. Qhov tau txais kev pab yog nyob rau ntawm tsev neeg cov nyiaj tau los ntawm cov me nyuam muaj npe.

Emergency Shelters (ES)

Cov chaw nyob thaum muaj xwm kub ceev uas pub zaub mov rau cov hluas thiab me nyuam tsis muaj tsev nyob hnuv nyoog txog 18 xyoo yuav tau txais kev pab them nyiaj rov qab txog peb pluag tauj ib tug neeg tauj ib hnuv.

Adult Day Care Centers (ADC)

Cov chaw zov cov muaj hnuv nyoog muaj ntawv tso cai los yog ntawv pov thawj uas muab kev pab muaj paus ntsis, txhij txhua rau cov muaj hnuv nyoog uas muaj teeb meem pab tsis tau tus kheej los yog muaj 60 xyoo rov saud yuav tau txais kev pab them nyiaj rov qab txog ob pluag mov thiab ib pluag khoom txom ncauj los yog ob pluag khoom txom ncauj thiab ib pluag mov tauj ib tug neeg tauj ib hnuv.
