Greetings Wisconsin Private Schools and Interested Parties,

The purpose of this email is to provide a last update prior to the EANS application window closing this coming Monday, April 12th. The focus of the email is on the application process. Look for another update next week with information about allowable expenses, the CESA Catalog, and other next steps.

## **The EANS Application will close at 11:59 pm on April 12th.**

**If you have not completed your application, please make sure to do so no later than Monday. The application will not be accessible after 11:59 pm on the 12th.**

The last scheduled batch of new applications went out today. We will continue to monitor application requests at [this link](#) just in case there are any stragglers, but we are not currently planning to send surveys out on Monday.

### **I completed my school's application. What's next?**

We are reviewing applications on a rolling basis. DPI will approve or deny applications within 30 days of receipt. As such, schools that submitted applications on March 12th will be the first to receive communication from DPI regarding their application status.

### **What happens when I receive my acceptance letter for the EANS program?**

As noted above, DPI continues review of submitted EANS applications, and will send acceptance or denial letters on a rolling basis.

Schools accepted into the EANS Program should know

- The acceptance letter will not yet provide information about how much money will be available for your school to access as reimbursement or direct service and assistance.
- DPI can only finalize allocation amounts after all applications have been reviewed.
- We plan to have final allocations by the end of May.
