- SUBJECT: Upcoming 2013-2014 PI-1202 Fall Staff Report data collection.

For the 2013-2014 school year, there are changes to the data collection timeline and a few assignments. Changes to Assignment codes are listed below under Additions, Deletions and Changes. The data collection timeline has been changed this year; the application will be opening Mid-September.

The project to enhance the PI-1202 application has been moved 2014-2015 school year. We do plan on upgrading and enhancing the PI-1202 application. Some of the anticipated enhancements include upgrading the application to current programming technology, making the PI-1202 open year round for data collection and real time preliminary audit checks. We will keep you posted as details come forward.

November 8 <sup>th</sup> November 11th	Reporting deadline and closing of the Fall Staff Report Or <b>7</b> weeks after collection opens.	
November	DPI will start running audits where the PI-1202 has been locked and submitted. Once audits are complete, if needed, districts can make corrections based upon audit results.	
March 1st	All final corrections must be done and the collection locked.	
April 30th	Staff data reports will be published on the DPI web site.	
May 31st	DPI's due date to report information to the U.S. Dept of Education.	
First week in July	Final audits to determine highly qualified teacher status are run at the end of the school year.
