## Wisconsin Act 251

We've previously outlined the changes made under 2017 Wisconsin Act 251 in regards to notice to schools for Permanency Plan reviews. In this issue, we take a closer look at another provision with major impact on districts. Under the Act, [Wis. Stat. sec 118.125\(4\)](#) was changed to require LEAs to transfer records "No later than the next working day." This means once an LEA that a student previously attended receives notice of enrollment in a new school, the LEA must transfer pupil records to the new school no later than the next working day.

The statute applies to all students, not just those living in out-of-home care. In your role as a Foster Care Point of Contact, you help maintain the education stability of all students when you ensure your district has the policies and procedures established to ensure pupil record transfer occurs in a timely fashion required under law. The [Wisconsin Legislative Council Act Memo](#) gives a quick breakdown of each of the changes made under Act 251.

## ABA Transportation Tool

The American Bar Association's Legal Center for Foster Care & Education has developed multiple resources to assist LEAs in developing or revising their transportation procedures. [This guidance document](#) provides insight into the requirements and potential options, when working with other LEAs and child welfare agencies, to develop transportation procedures and ensuring students have transportation when necessary. There are templates available to support [policy development](#) and [individual student transportation plans](#).



Each LEA must develop and implement clear written transportation procedures to ensure students placed in out-of-home care are able to continue attending their school of origin without disruption. These procedures must outline how the transportation will be provided, arranged, and funded for the time the student is placed in out-of-home care. These procedures should be developed in collaboration with the local child welfare agency.
