Back to School 2022

New School Year Tips:

As the school year begins, it is a good time to review district practices to remove barriers and support students experiencing homelessness. All LEAs must identify a homeless liaison. If the homeless liaison has changed, please use the instructions on this page to update the DPI school directory: https://dpi.wi.gov/homeless/liaisons.

Homeless liaisons must:

- Contact each family/youth who was in a homeless situation at the end
 of the 2021-22 school year to determine eligibility based on their
 current living situation for the 2022-23 school year. Students should
 not automatically be identified as homeless for the new school year.
- Identify new students enrolling in the district that are eligible for services under McKinney-Vento. The district's enrollment process should include a way for families to self-identify as experiencing homelessness. The homeless liaison must determine eligibility for those who self-identify. The DPI homeless website has many <u>sample</u> <u>forms</u> to help with the enrollment and identification process.
- Train all staff in your district on McKinney-Vento and the process to refer students to the homeless liaison. McKinney-Vento requires all staff to be trained at least annually. It is particularly helpful at the beginning of the year to remind staff of the definition of homelessness and ensure staff know the rights students have under McKinney-Vento. There are many creative ways to ensure this requirement is met.
 - The DPI EHCY webpage has a <u>short video</u> and a <u>training</u> <u>module</u> that can be used for staff training.
 - SchoolHouse Connection provides <u>resources for homeless</u> <u>liaisons</u>, including tools to train staff.
- Provide awareness of youth homelessness in your school and community. The National Center for Homeless Education has <u>free</u> <u>resources</u> available.

American Rescue Plan - Homeless Children and Youth (ARP-HCY)

During the 2021-22 school year, DPI distributed approximately \$7.6 million in ARP-HCY funds to Wisconsin LEAs. All ARP-HCY funds have now been distributed. ARP-HCY funds are to be used specifically to support students experiencing homelessness.
