FAFSA Resources

SchoolHouse Connection recently updated their website with <u>FAFSA</u> information for students, school staff, and higher education. Their website includes sample form letters to determine independent student status of unaccompanied homeless youth, as well as strategies to assist youth and information on how the pandemic has affected FAFSA.

Mental Health Law 204

In April 2018, a Wisconsin State Law passed to ensuring that unaccompanied youth can immediately access outpatient mental health services without a parent/guardian signature. While schools continue to be virtual for many students, this may be a time more youth need mental health services. Part of this law includes a 30-day window to petition the Mental Health Resource Office in their county to continue services.

Mini Grant Opportunity

The DPI EHCY team will be offering the opportunity for districts around the state to apply for a mini grant. The purpose of the grants is to help districts ensure they are in compliance with the McKinney-Vento Act. This will be a two-year grant beginning in the 2021-22 school year. More information will be available this spring, but districts are encouraged to start thinking about how this grant may support their work.

McKinney-Vento Monitoring

Any district may be monitored for compliance with the McKinney-Vento Act in a year. This school year DPI will be monitoring about 30 school districts. If your district is being monitored, you have already received notification.

We encourage districts to review the monitoring resources even if you will not be monitored this year. All of the resources are on the EHCY <u>website</u>, including the guidance document. Our <u>Example Forms and Documentation webpage</u> has many resources available for you to use and adapt for your districts.

New Liaison Required Training

Reminder that new liaisons must complete required training by November 6, 2020. All new liaisons and District Administrators received a memo on September 15, 2020 with information on options for required training. This training is also required for homeless liaisons who were updated in the school directory after September 15th. Please let the DPI EHCY team know if you have questions.
