**Sample Enrollment Language for the Identification of Agricultural Migratory Students and Students Experiencing Homelessness**

All Local Educational Agencies (LEAs) must have processes supporting the identification of eligible agricultural migratory students and students experiencing homelessness. Screening questions help gather some minimal information for eligibility referrals during an enrollment process. The following questions and resources are examples an LEA could implement in their enrollment process to support their identification and referral processes.
