Dear Wisconsin Parental Choice Program (WPCP) School Choice Administrators and Designees and Interested Parties,

Wisconsin Act 185, signed by Governor Evers on April 15, 2020, changes two deadlines related to student applications for the WPCP, for the 2020-21 school year:

1. **WPCP Application Period Deadline** - The deadline for a private school participating in the WPCP to accept WPCP applications and receive supporting documentation was changed from April 16, 2020 to May 14, 2020.
2. **WPCP Application Verification Deadline** - The deadline for a private school participating in the WPCP to complete the verification process of applications in the Online Application System was changed from May 1, 2020 to May 29, 2020.

Due to these deadline changes, schools participating in the WPCP will submit the **Final WPCP Seats Report** in the Online Application System between June 1, 2020 and June 4, 2020.
