For Private Schools: Before the end of a 7-year period beginning on the date of an order issued by the state superintendent, a private school participating in the MPCP, or RPCP and WPCP may not retain a disqualified person, for compensation or as a volunteer, as an owner, officer, director, trustee, administrator, person designated by the administrator to assist in processing pupil applications, or person responsible for administrative, financial, or pupil health and safety matters.

Disqualified Persons: Disqualified persons are prohibited from having an ownership interest in or serving as an officer, director, trustee, administrator, administrator designee or person responsible for administrative, financial or pupil health and safety matters, for compensation or as a volunteer, at another private school participating in the same program(s) for seven years from the date of the state superintendent's order barring or terminating the private school from the program(s).
