

## RACINE PARENTAL CHOICE PROGRAM (RPCP)

### RPCP Facts and Figures for 2015-2016 As of October 2016

In January 2016 there were nineteen (19) private schools participating in the RPCP, with a total enrollment of 2,131 students or 2,058.7 full-time equivalent (FTE) in the program.\* In the 2015-16 school year, the state aid for a student enrolled full-time in the RPCP is \$7,214 (for students in grades K4-8), or \$7,860 (for students in grades 9-12). The program is estimated to cost \$15.1 million in 2015-16.

Act 55 (Wisconsin 2015-17 Biennial Budget) changed the manner in which the RPCP is funded. Students that participated in the program prior to the 2015-16 school year will continue to be fully funded from state general purpose revenue.

Pupils who begin attending a private school under the RPCP in the 2015-16 school year and thereafter are referred to as “incoming pupils.” Racine Unified School District (RUSD) will have its state general aid reduced by an amount equal to the amount paid by the state to participating private schools attributable to the incoming pupils.

If RUSD does not receive an equalization aid payment sufficient to cover the incoming choice pupil aid reduction, the balance would be reduced from other state aid received by the district. Incoming pupils in the RPCP are included in RUSD’s membership for state general aid purposes in the following year. The district may not levy to backfill the aid reduction. School districts receive a non-recurring revenue limit exemption equal to the number of FTE choice students multiplied by the current year revenue limit per student.

Table 1 shows the RPCP enrollment by grade level for the 3<sup>rd</sup> Friday in September 2015 and 2<sup>nd</sup> Friday in January 2016 count dates. The number of students listed in the table is reported by headcount and FTE. For example, a four-year-old kindergarten student may be counted as 0.5 or 0.6 FTE.
