Allowable Costs: Costs incurred will be allowable under the principles established in the Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards; Final Rule [2 CFR Subpart E—Cost Principles]

Budget Modifications: The grantee will obtain an approved budget amendment when it is anticipated that claimed expenditures will vary significantly from the amount in the current approved budget. A significant variance is an increase of 10 percent (summary of all line items) of the current total approved budget. Programmatic Changes: The grantee will obtain the prior approval of the WDPI whenever any of the following actions is anticipated: (1) Any revision of the scope or objectives of the project; (2) Changes in key persons where specified in the application or grant award; (3) A disengagement from the project for more than three months, or a 25 percent reduction in time devoted to the project, by the approved project director; (4) Contracting out or otherwise obtaining services of a third party to perform activities central to the purpose of the award; (5) Changes in the amount of approved cost-sharing or matching provided by the subrecipient. [2 CFR §200.308(c)(1, 2, 3, 6, 7)].

13. The recipient agrees the project will be implemented according to the approved plan submitted in the grant application.
14. The recipient shall perform the work and services described in the grant proposal, including any amendments submitted to meet specific conditions.
15. The recipient shall conduct the project in accordance with grant assurances.
16. Expenditure is limited to the amount in the approved application. Any variance must be approved prior to initiation.
17. All 2015-16 activities funded by this grant must be completed and all funds must be encumbered by June 30, 2016.
18. A final program fiscal report (PI-1086) must be received by the Department of Public Instruction (DPI) no later than September 30, 2016.

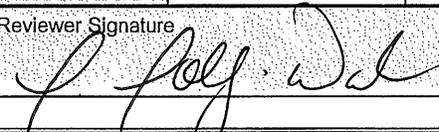
