Please make sure to read the entire memo for important updates and forward it to the staff member responsible for updating the online contract for the USDA School Meal Programs.

### **Online Contract Renewal**

All SFAs participating in any combination of the following School Nutrition Programs, the National School Lunch Program (NSLP), School Breakfast Program (SBP), Afterschool Snack Program (ASP), Seamless Summer Option (SSO), Special Milk Program (SMP), and Wisconsin School Day Milk Program (WSDMP) must renew their contracts online each year.

The SY 2023-24 contract includes program operations between July 1, 2023 – June 30, 2024, including summer meals provided after July 1.

# Before Updating the Online Contract, please review the following materials:

- 2. <u>Permanent Agreement/Policy Statement:</u> This document outlines requirements for participation in the USDA School Meal Programs. Make sure you read it prior to agreeing to the terms and conditions of this document.

## **Documents and Information Required for the SY 2023-24 Online Contract**

#### 1. Meal Purchase Contracts

Upload a SY 2023-24 meal purchase contract, if applicable:

- Vended Meals Agreement
- Joint Agreement with another SFA

Be sure to use the most current <u>Vended and Joint Meal Agreements</u>. \*This is <u>not</u> for the prime vendor agreement or FSMC agreement.

#### 2. Paid Lunch Equity (PLE)

For SY 2023-24, only SFAs that had a negative balance in the nonprofit school food service account as of June 30, 2022, shall be required to establish a price for paid lunches served through the NSLP in accordance with section 12(p) of the Richard B. Russell National School Lunch Act. Any SFA with a positive or zero balance in its nonprofit school food service account as of June 30, 2022, is exempt from paid lunch equity pricing requirements found at 7 CFR 210.14(e) for SY 2023-24. USDA has not released the 2023-24 PLE tool and memo yet, additional guidance is forthcoming.

## 3. Alternate Authority Agreements (if applicable)

All SFAs that are in an <u>Alternate Authority Agreement</u> with another SFA must upload an annual renewal of this agreement into the contract.
