INSTRUCTIONS FOR REPORTING

General Information (G1-G6): For SFAs selected to conduct the second reviews of applications, enter the SFA agency code, name of SFA, and the appropriate school year and contact information for the person completing the form.

Overview:

O1: Total number of schools in SFA.

O2: Total number of enrolled students in SFA.

O3: The total number of reviewed applications (includes <u>all</u> applications, **both those determined eligible** and ineligible in the initial application review). Value should equal the sum of the categories (O4 + A1 + B1 + C1).

O4: The total number of applications in the SFA whose eligibility determinations changed as a result of the Second Review of applications. This includes the count of changes in eligibility determinations for all applications, both those determined eligible and ineligible in the initial application review. Value should equal the sum of the following categories: (A2(a-d); A3(a-d); B2(a-d); B3(a-c); C2(a-d); C3(a-d)).

Results of Second Review:

This section captures information about the results from the second review of applications. All applications reported in O3 must be reported in this section (e.g., applications that were determined <u>ELIGIBLE</u> and INELIGIBLE during the <u>INITIAL</u> application review).

For each initial eligibility determination (A, B, & C), report the number of applications for each result category (1, 2, & 3) – See Table on next page. For applications with a changed initial eligibility determination, report the number of applications in each error source category that resulted in the eligibility determination change (only report in one error source category for each application). In some scenarios, one or more of the error sources may not be relevant. Error sources are as follows:

a. Incomplete application error examples

- lack of application signature,
- lack of SSN (last four digits),
- missing income value for household member(s),
- missing case numbers (i.e., Food Share or W-2 Cash Benefits),
- other missing information that is necessary for an eligibility determination.

b. Categorical eligibility error examples

- invalid case numbers/identifiers,
- categorical eligibility claims known to be false,
- invalid categorical standards.

c. Gross income calculation error examples

- incorrectly calculating household size,
- incorrectly determining the frequency of receipt of income,
- not converting multiple income sources to annual income,
- not counting the child in the list of household members or counting the child twice,
- incorrect arithmetic,
- misclassifying reportable income,
- other income computation errors.

d. Other errors

Any errors that are not included in the other categories that caused a change in eligibility determination or benefit level during the second review of applications.

<u>A1, B1, & C1</u>: The total number of applications, by initial eligibility determination, that did not result in a change in eligibility determination or benefit level.

<u>A2</u>: The total number of applications Determined as FREE during the initial review of applications that changed to REDUCED PRICE due to the second review. Value should equal the sum of the error source categories under 1-5A2 (a, b, c, & d).

<u>A2a-d:</u> The number of applications with changes in eligibility determination by each error source.

<u>A3</u>: The total number of applications Determined as FREE during the initial review of applications that changed to PAID due to the second review. Value should equal the sum of the error source categories under 1-5A3 (a, b, c, & d).

<u>A3a-d:</u> The number of applications with changes in eligibility determination by each error source.

<u>B2</u>: The total number of applications Determined as REDUCED PRICE during the initial review of applications that changed to FREE due to the second review. Value should equal the sum of the error source categories under 1-5B2 (a, b, c, & d).

B2a-d: The number of applications with changes in eligibility determination by each error source.

<u>B3</u>: The total number of applications Determined as REDUCED PRICE during the initial review of applications that changed to PAID due to the second review. Value should equal the sum of the error source categories under 1-5B3 (a, b, & c).

B3a-c: The number of applications with changes in eligibility determination by each error source.

<u>C2</u>: The total number of applications Determined as PAID during the initial review of applications that changed to FREE due to the second review. Value should equal the sum of the error source categories under 1-5C2 (a, b, c, & d).
