School Year 2016-17 Paid Lunch Equity (PLE) Tool Step by Step Instructions

Important – Save the final 2016-17 PLE Tool Excel file to your computer. You will be required to upload this Excel file when you submit your Child Nutrition Online Contract. Be sure you and the person that completes the online contract have access to this file.

Use these instructions if you plan on increasing the weighted average paid lunch price to meet the requirement.

*The weighted average price for School Year (SY) 2016-17 is **\$2.78**.*

You will need the following information to calculate the Weighted Average Price for SY 2016-17:

- SY 2015-16 Unrounded Price Requirement from your SFA's 2015-16 PLE Tool, *Report Tab (Section 1A)*
- All paid lunch prices for October 2015
- Number of paid lunches served associated with each paid lunch price in October 2015

If you did not complete the PLE Tool for SY 2015-2016, you will need:

- All paid lunch prices for October 2010 and October 2015
- Number of paid lunches served associated with each paid lunch price for October 2010 and 2015

School Year (SY) 2016-17 Paid Lunch Equity (PLE) Tool Instructions
Note: Users may want to print the instructions and use them to guide users through the PLE Tool.

The PLE Tool was created to help School Food Authorities (SFAs) calculate their paid lunch price increase requirement and/or non-Federal source contributions to meet the requirements in 205 of the Healthy, Hunger-Free Kids Act of 2010. If the pricing requirements calculated by the PLE Tool are not met or are exceeded, the PLE Tool will also calculate any amounts, including credits or deficits carried over into the next year. Note, the weighted average prices calculated in the PLE are the weighted average of all student paid lunch prices charged in the SFA.

TIPS:

- 1) Have last year's PLE Tool available for reference
- 2) Were credits carried over from last year?
- 3) Is the current weighted average paid lunch price above the requirement?
- 4) Only the tab(s) relevant to the SFA's selection of method to meet PLE requirements need to be completed
- 5) The \$.10 cap does not mean that every SFA will raise the weighted average paid lunch price or contribute the equivalent in non-Federal funds. Depending on where the SFA is at in regards to meeting the PLE requirement, they may need to contribute less than \$.10 or may choose to contribute more than \$.10.

This version of the PLE Tool is only applicable to SY 2016-2017. A new version of the PLE Tool will be issued for SY 2017-2018



SY 16-17 Price Calculator

The *Required price increase for SY 2016-17 (with 10 cent cap)* box shows the required weighted average price the district must attain in SY 2016-17 to be in compliance with Paid Lunch Equity. This number is calculated by adding the district's *October 2015 Weighted Average Price* plus the figure from the *Total Price Increase for SY 2016-17* box up to \$0.10.

If your school has different prices for separate grade groupings, you will need to complete the *Step 3 (Optional)*, to determine how to apply the increase to the various grade groupings. This can be found further down on the current page of the PLE Tool.

Note: SY 2015-16 Weighted Average Price equal to or above \$2.78 are compliant for SY 2016-17. \$2.78 is the difference between the Free and Paid reimbursement rates for SY 2015-16.

Enter the number of October 2015 paid lunches, and then alter the prices to meet the new required Weighted Average Price. The new weighted average price should be at least equal to the amount in the *required price increase for SY 2016-17 (with 10 cent cap)* box (shown above in the purple box).

SY 2016-17 Report Tab

If you have decided to increase the price of the paid lunch to meet the SY 2016-17 Weighted Average Price Requirement, you will need to click the drop down box arrow and select *Increase SY 2016-2017 average weighted price*. Enter your weighted average price from the *Step 3 (Optional) Pricing Estimation Calculator*.

If no price increase was required, select *At or above equity* from the drop down box. Enter your weighted average price in the box that appears just below the drop down. This can be calculated on the *SY 15-16 Price Calculator* tab. If you have only one paid student meal charge, enter this price as it will be for SY 2016-17. If you have multiple paid student meal charges but are at or above equity as determined by the PLE tool, use the *SY 2015-2016* tab to determine the weighted average price to enter. If your paid student meal charges for SY 2016-17 will remain the same from SY 2015-16, follow the instructions as is on the page. If you plan to increase any or all of your paid student meal charges in SY 2016-17, use SY 2015-16 *Monthly # of Paid Lunches* figures and alter the respective *Paid Lunch Prices* to be charged in SY 2016-17 to determine your SY 2016-17 weighted average price. Enter this figure on the *Report* tab in the box titled *Enter the SY 2016-2017 average weighted paid lunch price here*.
