<sup>&</sup>lt;sup>1</sup> A school is eligible for severe need reimbursement if 40 percent or more of the student lunches served at the school in the second preceding school year were served free or at a reduced price. Severe need payment is made on an individual school basis. Documentation of eligibility must be kept on file by the SFA for periodic review. Severe need breakfast eligibility determination is part of the annual DPI School Nutrition Team online contract renewal. Due to the COVID-19 pandemic, USDA Memo SP 02-2023 allows flexibility on the year used to qualify.

<sup>&</sup>lt;sup>1</sup> If 60 percent or more of the student lunches served in the second preceding school year were served free or at a reduced price, the reimbursement is an additional two cents per lunch. Per <u>SP 02-2023</u> due to COVID, SFAs that operated NSLP in 2022-23 will use data from Sept-Nov 2022 to establish eligibility.

<sup>&</sup>lt;sup>2</sup> USDA regulations require that the reduced price charge to students does not exceed 30 cents for breakfast.

<sup>&</sup>lt;sup>3</sup> For additional information about these funds, please reference the <u>State Aid Payments Received in May 2023</u> memos. Independent Charter schools, Residential Childcare Institutions (RCCIs), Wisconsin Technical College System schools, and the two State-run schools are not eligible for the State breakfast payment.

<sup>&</sup>lt;sup>2</sup> In Wisconsin, following initial Menu Certification, all SFAs receive Performance Based Reimbursement (PBR), an additional \$0.08 per meal. However, PBR may be disabled due to noncompliance with regulations.

<sup>&</sup>lt;sup>3</sup>USDA regulations require that the reduced price charge to students does not exceed 40 cents for lunch.

<sup>&</sup>lt;sup>4</sup> Residential Child Care Institutions (RCCIs) and Wisconsin Technical College System schools are not eligible for the State lunch aid payment.

<sup>&</sup>lt;sup>1</sup>An afterschool care program site is "area eligible" if it is located at a school or in the attendance area of a school where at least 50 percent of the enrolled children are eligible for free or reduced price meals. All snacks served in afterschool care programs that are "area eligible" are reimbursed at the free rate.

Snacks served in afterschool care programs that are not area eligible are reimbursed at the free, reduced price, and paid rates, depending on each students' individual eligibility for free or reduced price meals.

<sup>2</sup> USDA regulations require that the reduced price charge to students does not exceed 15 cents for afterschool snacks.
