



ORDER OF SCHOOL DISTRICT REORGANIZATION
Based on Consolidation

The boards of education of: School District Number 22, Town of Herman, Dodge County, Wisconsin (the "Herman #22 District"), Joint School District Number 3, Village of Neosho, Towns of Ashippun, Herman, Hubbard, Hustisford, Lebanon, and Rubicon, Dodge County, Wisconsin (the "Neosho J3 District"), and Rubicon Joint #6 School District, Towns of Rubicon and Hartford, City of Hartford, Dodge County, Wisconsin (the "Rubicon J6 District"), acting pursuant to the provisions of s. 117.17, Wis. Stats., do hereby order that the following school districts be dissolved, to wit: Herman #22 District, Neosho J3 District, and Rubicon J6 District, and that the new school district be created comprising all the territory included in the aforementioned dissolved school districts.

It is further ordered:

1. The name of the new school district as established by a resolution of the new school board will be: School District of Herman-Neosho-Rubicon as provided in s. 115.01(5), Wis. Stats.
2. The type of school district structure will be: Common under s. 115.01(3) and will operate under this provision of Chapter 120, Subchapter 1.
3. The grades to be taught in the newly created school district will be Pre-Kindergarten through Grade 8, under s. 115.01(2), Wis. Stats.
4. The school board of the newly created school district will be composed of five members, under s.120.01, Wis. Stats.
5. The method of election of school board members of the newly created school district will be at large in accordance with s. 120.06, Wis. Stats. The terms of the initial members of the consolidated school district board, pursuant to s. 120.02(3)(a), Wis. Stats., shall be as follows:
 - a. The two candidates receiving the highest (first and second) number of votes will be awarded three (3) year terms.
 - b. The two candidates receiving the next highest (third and fourth) number of votes will be awarded two (2) year terms.
 - c. The candidate receiving the next highest (fifth) number of votes will be awarded a one (1) year term.
6. The date of election of the first school board of the newly created school district will be the 5th day of April, 2016, under s. 117.22(2)(b), Wis. Stats.
7. The time and place of the first annual meeting of the newly created district will be 6:00 p.m. on the 27th day of October, 2016, at 201 Center Street, in Neosho, Wisconsin in accordance with s.117.17(1), Wis. Stats.
8. The effective date of this reorganization will be the 1st day of July, 2016, in accordance with s. 117.08(2), Wis. Stats.






