### Task force to make recommendations for indoor environmental quality in schools

MADISON — The task force charged with making recommendations for indoor environmental quality in the state's schools began its work at 9 a.m. Wednesday, March 3, at the Crowne Plaza Hotel in Madison.

Appointed by State Superintendent Tony Evers based on membership designated in state law, the Indoor Environmental Quality in Schools Task Force is made up of representatives from schools, government, and professional organizations. The 17-member task force will make recommendations to the Department of Public Instruction for its development of a model management plan to address both the long-term and short-term health and safety of students and school staff members.

“The quality of the indoor environment in our schools contributes to the success of our students and the effectiveness of our teachers,” Evers said. “The members of this task force will bring a wealth of knowledge and expertise to the development of these important health and safety recommendations.”

Established by 2009 Wisconsin Act 96, the task force is expected to meet about five times between March and the end of the year and will appoint a chair or co-chairs at its first meeting. The task force will make its recommendations to the appropriate standing committee of the Legislature and the governor. Then, the DPI will use the group's recommendations to develop a model management plan and practices for maintaining indoor environmental quality in public and private schools. The task force will dissolve after the DPI issues its model management plan.

Task force recommendations will include indoor environmental quality training requirements, model specifications for the design and construction of school facilities and for additions and structural alterations to school facilities, and recommended educational materials relating to indoor environmental quality in schools.
