- h. Special Education Team Director's Report
  - i. Courtney Jenkins read special education director's report. There was discussion about the rule changes and questions from council related to the specific changes in the emotional behavioral disability rule.   - ii. Council asked, "If the rule change for any of the areas of impairment gets filed after September 1, would evaluation teams be required to follow the rule change if the referral had been made but the evaluation team has yet made a determination, or would it only take effect for referrals that begin after the implementation date?" IEP teams must implement the criteria outlined in a new rule for any referral for special education received by the Local Educational Agency, e.g. school district, on or after the day the rule goes into effect. For referrals made prior to the effective date of any new rule, the IEP team uses the criteria from the previous rule to assist in determining special education eligibility.
- i. Introduce Assistant State Superintendent and Remarks and Awards to Outgoing Council Members
  - i. Courtney Jenkins introduced Barb Van Haren to present awards to departing council members. Barb is retiring July 5, 2021. Barb Van Haren presented recognition to 11 outgoing council members and shared brief remarks on her retirement and appreciation for council and the work they have done during her time at Wisconsin DPI.
