

## IDEA Grants Management Timeline

- June 30, 2010** – Last day to obligate 2009-2010 entitlement funds.
- July 1, 2010** – Required assurances and budgets for 2010-2011 regular entitlement grants due.
- July 15, 2010** - Final 2010-2011 entitlement budget amendments are due.
- August 31, 2010** –Quarterly ARRA financial claims are due for reporting period February 17, 2009, through August 24, 2010.
- September 16, 2010** - Quarterly ARRA vendor/job impact surveys will be sent to LEAs.
- September 23, 2010** – Quarterly ARRA vendor/job impact surveys are due.
- September 20, 2010** – PI-1505 Special Education Annual Reports for 2009-2010 are due.
- September 30, 2010** – Last day to submit financial claim for 2009-2010 entitlement funds.
- October 15, 2010** – First quarterly 2010-2011 regular entitlement financial claims are due for the period July 1 through September 30, 2010.
- November 1, 2010** – Last day to submit 2010-2011 Coordinated Early Intervening Services (CEIS) regular entitlement budgets. Amendments are permitted after November 1, but the total CEIS funds budgeted may not be increased. Unspent budgeted CEIS funds may be reverted back to regular flow-through.
- November 23, 2010** - Quarterly ARRA financial claims are due for reporting period February 17, 2009, through November 16, 2010.
- December 9, 2010** - Quarterly ARRA vendor/job impact surveys will be sent to LEAs.
- December 16, 2010** - Quarterly ARRA vendor/job impact surveys are due.
- December 3, 2010** – PI-1504 Special Education Budget Reports for 2010-2011 are due.
- January 14, 2011** – Second quarterly regular entitlement financial claims are due for expenditures through December 31, 2010.
- March 2, 2011** - Quarterly ARRA financial claims are due for expenditures through February 23, 2011.

**March 17, 2011** – Quarterly ARRA vendor/job impact surveys will be sent to LEAs.

**March 24, 2011** - Quarterly ARRA vendor/job impact surveys are due.

**April 15, 2010** – Third quarterly regular entitlement financial claims are due for expenditures through March 31, 2011.

**June 1, 2011** – Quarterly ARRA financial claims are due for the expenditures through May 25, 2011.

**June 16, 2011** – Quarterly ARRA vendor/job impact surveys will be sent to LEAs.

**June 23, 2011** – Quarterly ARRA vendor/job impact surveys are due.

**June 30, 2011** – Last day to obligate 2010-2011 regular entitlement funds.

**July 15, 2011** - Final 2010-2011 regular entitlement budget amendments are due.

**August 30, 2011** - Quarterly ARRA financial claims are due for the expenditures through August 23, 2011.

**September 15, 2011** - Quarterly ARRA vendor/job impact surveys will be sent to LEAs.

**September 22, 2011** - Quarterly ARRA vendor/job impact surveys are due.

**September 30, 2011** - Fourth quarterly (final) regular entitlement financial claims are due for expenditures through June 30, 2011.

**September 30, 2011** – Last day to obligate ARRA funds.
