**Reducing and Responding to Sexual Violence Resources**

- **DPI Mandated Reporting Trainings and Resources**
  - School boards are to ensure all employees receive training **provided by the Department of Public Instruction** within six months of initial hiring and at least every five years thereafter, Wis. Stat. sec. 118.07(5). This page contains online trainings, as well as power points that could be used to provide local training.
- **Protective Behaviors**
  - **(d) Personal development.** Each school board shall provide an instructional program designed to give pupils:....
    - 118.01(2)(d)8. Knowledge of effective means by which pupils may recognize, avoid, prevent and halt physically or psychologically intrusive or abusive situations which may be harmful to pupils, including child abuse, sexual abuse and child enticement. Instruction shall be designed to help pupils develop positive psychological, emotional and problem-solving responses to such situations and avoid relying on negative, fearful or solely reactive methods of dealing with such situations. Instruction shall include information on available school and community prevention and intervention assistance or services and shall be provided to pupils in elementary schools.
  - **[Awareness to Action](#)**
    - This group provides resources and training in child abuse prevention in schools. They have **[a guide](#)** to help with choosing a curriculum.
- **Anti-Human Trafficking**
  - Sex trafficking is included in the definition of child abuse, and therefore mandated reporters must report to CPS or law enforcement when they have a reasonable cause to suspect abuse has or will occur. A Wisconsin Child Sex Trafficking and Exploitation Indicator and Response Guide is
