# WISCONSIN EDUCATIONAL OPPORTUNITY PROGRAMS EARLY IDENTIFICATION PROGRAM

## 2019-2021 Biennial Report

Under s. 115.44(2), Stats., the State Superintendent must provide the governor and any appropriate standing committee of the Legislature information on the performance of the early identification program and the postsecondary educational progress of the pupils who were enrolled in the program.

### Background on the Early Identification Program

Under s. 115.44(1), Stats., the State Superintendent must establish an Early Identification Program as part of the Wisconsin Educational Opportunity Program. The Early Identification Program must assist minority and economically disadvantaged pupils in grades 8 to 12 in pursuing higher educational opportunities by providing direction toward attainment of career goals.

Types of services provided to students may include the following:

- Personal and career counseling;
- Academic advising;
- ACT preparation;
- College visits;
- Mentoring; and
- Cultural field trips.

Students and parents have the opportunity to participate in workshops on various topics such as:

- High School Graduation Credit Requirements vs. College Admission Credit Requirements;
- College admissions process;
- Completing the FAFSA and how to pay for college;
- Summer precollege program opportunities;
- Exploring the world of work; and
- Study Skills & Learning Styles.

Special Events that are part of the Early Identification Program include:

- National GEAR UP Week in September;
- Annual College Application Week in November;
- Precollege Fair; and
- Annual Awards Banquet.

The EIP's activities take place at the school during the day in the form of office hours, after school in the form of workshop presentations, and/or during monthly weekend/evening workshops held on college campuses.
