

WISEdata Release Notes: 9/28/17

Title	Description/Comments
EdCred: Removed 'No Sped' API profile	We removed the 'No Sped' API profile from all our environments because it was causing confusion to SIS vendors and will no longer be needed.
Data Warehouse: Deleted records will no longer be selected for processing	Sometimes records were selected for processing when they had been deleted because the system was still checking Effective Dates. We cleared Effective Dates for deleted records. As an additional check against using these records, we set the Effective End Date to the day prior to the Effective Begin Date on sSA and sSEPA records when inactivating them.
WDP: Removed validation rule 6375	We removed validation rule 6375 because this data logic check is now covered by other sSA Effective Date rules. We also cleared the messages for 6375. It's currently active only for Choice schools now.
WDP: Enhanced logic for validation rule 6385	<p>Validation rule 6385 was not throwing if parentally-placed private (PPP) = T and the public school enrollment didn't include the 3rd Friday of September (TFS), but the receiving services value for TFS was submitted as Present, Absent, or Null.</p> <p>We have now modified the 6385 rule to throw</p> <ul style="list-style-type: none"> ● When public school PPP= T, ● enrollment does not include TFS, and

	<ul style="list-style-type: none"> Receiving Services TFS is either P or A (or N). <p>This will help public schools understand that they will not receive TFS credit.</p>
WDP: Bug Fix--Revised logic in Rule 6506 to throw properly	Validation rule 6506 should throw to the Expected Transfer Agency, but it was displaying for the Submitting School. We changed the logic to look at the Submitting District instead, so now the rule should throw properly.
WDP: Implemented Rule 6508	We implemented L2 validation rule 6508 - Required field is missing, 'Expected Transfer School'.
WDP: Updated Long Description for Rule 6717	The Long Description of validation rule 6717 has been updated. It now reads: Invalid 'Actual Discipline Action Length' for Suspension or IAES. 'Actual Discipline Action Length' for both Suspension or IAES is expected to equal length. These removals (Suspensions and IAES) cannot span into the next school year.
WDP: Bug Fix-- Rule 6606 is throwing properly now	Validation rule 6606 was throwing incorrectly for the 2017-18 school year, but it should only be thrown when there is no exit date for 2016-17. This bug has been resolved.
WDP: Dropouts Collection drop-down menu hidden until complete	We have hidden the Dropouts option from the Collections drop-down menu for public schools until all the development work is complete.
WDP: Student Details now shows Prior Year Enrollments History	We added Prior Year Enrollments History to the Enrollments panel in the Student Detail screen, so you can see the student's past enrollments.

<p>Roster: Added School Selection screen in Roster export</p>	<p>We added a school selection screen in the Roster export. This will allow districts to download a different school/multiple schools in their export, so they don't have to wait as long, especially for larger districts.</p>
<p>WDP: Enhancements to Count Inclusion sections in the Student Detail Screen</p>	<p>We made enhancements to the Count Inclusion sections on the Student Detail Screen, so the Count status flag shows in the section header with the count date determinants and other related data elements displaying underneath the Count Inclusion date section.</p>
<p>WDP: Bug Fix--Child Count export works properly</p>	<p>When trying to export for the 2017 school year, "Child Count" returns the message: "An error occurred while processing your request." This has been resolved now.</p>
<p>WDP: Bug Fix--Fixed Add Vendors process in Ed-Fi Credentials</p>	<p>In the Ed-Fi Credentials section in WISEdata, the Add Vendors process wasn't working correctly to allow schools to add special education vendors, such as SEEDS. This has been fixed, so vendors can now be added.</p>
<p>WDP: Bug Fix--Queue Validation button grays out once clicked for manual validation</p>	<p>Previously you could click "Queue validation" multiple times because it wasn't graying out once you clicked "Queue Validation" for manual validation. This was corrected, so now once you click the Queue Validation button, it will gray out until it has run.</p>
<p>Calculation: Modified Effective Date logic to only look at primary education service providers</p>	<p>We modified the Effective Date logic to exclude enrollments where the primary education services value was No. This way the Effective Date logic will only check against enrollments in schools providing the student's primary education services.</p>

<p>WDP: Bug Fix--Metrics now match the export data</p>	<p>In WISEdata Portal, the metric graphs for the Third Friday of September and Oct. 1 Child Count Collections weren't matching the same Collections' export data. This has been fixed, so the metric data now matches the export data.</p>
<p>WDP: Bug Fix--Acknowledged warnings clearing properly now</p>	<p>Acknowledged warnings were not clearing once a user acknowledged them, but this was resolved.</p>
<p>Calculation: Revised Max Age Year calculation in validation logic</p>	<p>We revised the Max Age Year calculation to use all schools for which the student has an enrollment in a given school year and the birth date from WISEid.</p>
<p>WDP: Bug Fix--2015-16 data only in validation queue for Choice data</p>	<p>2015-16 validations were running in the queue for public LEAs when only Choice schools submitted data to WISEdata for that school year, but this has been updated to only check 2015-16 data for Choice schools.</p>
<p>WDP: Bug Fix--Rule 6643 now shows School Name in message</p>	<p>Validation rule 6643 wasn't displaying the School Name in the message grid, but this was fixed.</p>
<p>WDP: Modified text for rules 6373 and 6374</p>	<p>We modified the L2 validation rule Short and Long Description text for rules 6373 and 6374.</p>
<p>WDP: Bug Fix--Rule 6377 throwing properly</p>	<p>The L2 validation rule 6377 for no enrollment for the school was throwing a warning when enrollments were present, but this was resolved to only throw when a school really doesn't have an enrollment.</p>
<p>WDP: Bug Fix--Rule 6474 throwing properly</p>	<p>The validation rule 6474 for no Actual or Possible Days of Attendance submitted was still displaying a warning for 2018 data when it shouldn't. This is fixed now.</p>

WDP: Queue Validation button works even if a system job is waiting

Users can now click the Queue Validation button to trigger a manual validation job if the only job waiting in the current LEA's queue is the general nightly SYSTEM job.
