

WISEdata Release Notes: 2/16/17

WORK ITEM	Description/Comments
WDP: A valid FAPE-Accountable School is required in an sSEPA.	A valid FAPE-Accountable School is now required in an sSEPA. You can't have a null value or spaces.
Validation: Bug Fix-- 6480 message displays appropriate text and includes Exit Date and Exit Type.	We revised the validation message for 6480 to update the script for 'name', 'short description', and 'long description'. Required fields, Exit Date and Exit Type were missing and now display.
Validation: All rules now check for IsPrimary = 1.	Fixed bug with rules where the rules weren't checking to see if the primary school was marked as Yes, True. Now the rules verify the primary school is marked as Yes.
Validation: Bug Fix-- Corrected error 6597 from throwing unnecessarily.	Error 6597 was throwing for schools when it shouldn't, so it was corrected by having the system look at the most recent sSEPA record.
Validation: Bug Fix-- 6613 now displays for any school that has this situation.	Error message 6613 was only appearing for a couple schools, not everyone who may've needed that validation message. This is now fixed.
Validation: Error 6659 will display if a CCDEB or State School lists itself as FAPE Accountable.	DPI expects all special education data submitted by State schools and CCDEBS to have Public Schools listed as the FAPE Accountable agency/school. Error 6659 should trigger now when a State school or CCDEB lists itself (or member schools) as FAPE accountable on an sSEPA.
Validation: Error 6632 has been reduced to a warning.	We changed 6632 to a warning and removed it from the rule actions table, so the coordinating data isn't rejected by the Data Warehouse.
Validation: Bug Fix-- Error 6379 Required Field missing 'English Proficiency' field now displays appropriately with associated enrollments.	When Error 6379 displayed, you couldn't see any enrollments for the student in WDP or the ARM. This is now corrected.
Validation: Calculations are run at night for additional validation accuracy.	We added a nightly job that runs the calculations that currently run on a daily schedule in WDP so that if we have to cancel

	jobs because of a production issue, we make sure that calculations aren't missed.
WDP: New red icon next to high-priority errors to fix. These messages also sort to the top of the list.	You will now see red icons to alert of high priority errors, so districts understand these errors will greatly impact data collection.
WDP: Agency contacts are sorted alphabetically.	For ease of use, agency contacts are now sorted alphabetically.
ARM: ARM works regardless of which browser you use to view.	An invalid date format was impacting ARM use in Chrome, but it has been resolved. You can now use the ARM with any browser.
WDP: You will now only see Acknowledgement checkboxes for warnings.	You will now only see Acknowledgement checkboxes on warnings instead of also on the Error views for the WDP messages.
API/EdCred: New claimset for SPED-only vendors and SIS vendors that shouldn't be sending SPED data.	SIS and SPED-only vendors were previously able to send SPED data that was not required. New claimset and profiles will prevent the SPED data from coming across to WISEdata.
API/EDCred: We've updated the environment to the new API version for improved functionality and bug fixes.	We brought the new API version into our environment because the release notes indicated it would resolve a number of critical bug fixes and improve functionality.
Validation: Temporarily disabled info message 6475 because it was negatively impacting the All Agency validation run.	Temporarily disabled info message 6475 because it was negatively impacting the All Agency validation run after its rule modification last week.
Validation: Bug Fix-- Errors 6604 & 6605 will now throw at the appropriate times.	Errors 6604 & 6605 were throwing incorrectly for students for which the rules didn't apply or when null values were coming in, but they will now throw correctly.
WDP: The All Agency job will now run faster so that LEAs see updated validation results faster.	We enhanced performance, so the All Agency job will now run faster, allowing LEAs to see updated validation results faster.
ARM: Expected Transfer Agency drop-down is now ordered alphabetically.	You can now search alphabetically through the Expected Transfer Agency drop-down list in the ARM.
