

## L2 Validations -

- [Warning 7445](#) (*Student with Section Exists but Staff Section Association is Missing*): This L2 was mentioned in the last Release Notes. However, it's being brought up again to emphasize that this warning applies to all courses, it has specific applications to Career and Technical Education (CTE) courses that are associated with a staff member who is not CTE-licensed. The KBA has been updated to reflect this new information and has a CTE and non-CTE example.
- [Error 6484](#) (*Exit Type expected to be 'Maximum Age' (MA)*): This error is still being utilized, but the logic has been adjusted to reflect that the exit type Prior Completion Credential (PCC) is no longer active for the 2022-23 school year. Information about deprecating the PCC exit type was shared in the June 14, 2022, Release Notes:
  - *The Data Element 'Exit Types' has a change for the 2022-23 school year. The Exit Type PCC (Prior Completion Credential) will no longer be used. An additional change is that we're implementing a new Exit Type, CE (Compassion Exit). It is important to know that CE is not a replacement for PCC. Each Exit Type has unique properties and must only be used for its intended purpose. Refer to the [Exit Types data element page](#) for specific details.*
- **NEW!** [Warning 7446](#) - "Missing Art Category for Grades 6-8" will be released as of October 18th. The warning will throw for schools when no students are submitted as taking any art courses in grades 6-8 within an LEA. Students in grade 6 are required to take a music course and an art course. Students in grades 7 & 8 need to be offered course options in the art field, and your agency should have students signed up for those courses.

The [snapshot landing page](#) also links out to all of the other available Snapshot ATD pages. Spring Demographics is the only one not yet available.
- **[WISEid: Info, Help and User Guide](#)** - There is now an updated section in the User Guide and Tutorial section of this webpage to explain the specifics behind change requests, emphasizing the need for comments when placing a 'name change' type change request, and the information those comments must contain for approval from DPI. There are also instructions and screenshots to show you what to do if your change request gets denied. This page is the 'one-stop-shop' for all information about WISEid, so it might be a good idea to bookmark it; previously existing 'Help' or 'FAQ' page information is now located here.
- **[WISEstaff: Info Help and User Guide](#)** - The User Guide and Tutorial section of this 'one-stop-shop' page is sporting completed revisions, which provides a detailed step-by-step to complete the [Staff Collection Checklist](#) for compliance with the annual

staff licensing audit. This is the sole page for all information about WISEstaff, so it might be a good idea to bookmark it; previously existing 'Help' or 'FAQ' page information is now located here.

- [WISEclassroom](#) - WISEclassroom is the training hub for all WISE applications. Located here is the full collection of e-Learning courses, Quick Training Videos and Mini-Tutorials.

### WISEdata Portal (WDP) Updates -

- **The Agency Contacts page now has email linked.** When you click the expander tool on the user name in the upper right corner of WISEdata Portal, 'Agency Contacts' will show up as an option. Clicking 'Agency Contacts' will reveal a screen displaying all of the SIS vendors associated with your agency. Email addresses for a point of contact for each SIS is listed, to assist users in contacting their SIS vendor representatives with questions.

### WISEdash Updates -

- **Perkins Snapshot Dashboard** - Added new dimension to both dynamic crosstabs called "Any WBL Program". If a student was part of any work-based program in the given year, this dimension will show "Yes"; otherwise, it will be "No".
