## **WISEdata Portal Updates**

#### WISEdata Portal: Change 'Career Pathways' to 'Clusters'

This label change is reflecting a name change so that consistent names and labels are reflected across platforms and areas in DPI. The new term 'clusters' will replace the term 'career pathways' for all current years in WISEdata Portal and will be visible on the Student Detail screen under the following headers:

- Roster panel
- School Roster details
- Programs > Career Education
- Career Education API View screen

#### WISEdata Portal: Certified/Not Certified CTE Errors

- Bug Fix: The Career Education Certified/Non-Certified Career Education Programs Errors has been glitching depending on a student's enrollment type: primary or coursework.
  - Grade levels are being pulled regardless of the student's enrollment type to help prevent glitches.

## WISEdata Portal: Roster Export Renamed: "Sections – Student and Staff Count."

The 'Sections Missing Staff' column on the Roster Export in WDP will be renamed to improve clarity because this column on the export displays more than just courses missing staff.

- The new column header will be "Sections Student and Staff Count."
- The new description will read, "This export includes records at the school level, including the number of students and staff information associated with a course. The export displays all records with sections and counts associated with students and staff.

#### **KBAs for Validations**

7127: Updated Logic

<u>Error 7127</u> is about a graduation plan not meeting the minimum number of health credits. The logic for this error was repaired to improve accuracy. When users left the number of health credits blank, the error would throw, but if users entered the number of health credits as zero, the error was not throwing. The new logic causes this validation to throw only when the field for health credits is either blank or less than 0.5 credits.

6474: Performance Improvements Made

Warning 6474 is about zero attendance. This is a very important validation to run accurately because it is a large measure represented in snapshots/report cards for customers, as well as a few reports internal to DPI. Some programming adjustments were made to ensure this warning is throwing accurately.

## **CST and Other WISE Webpage Updates**

Updating WAMS Account When Changing Districts: Redirect is in Effect The <u>Updating WAMS Account When Changing Districts webpage</u> has received a new URL. Previously, WAMS content was nested under "WISE" but due to it's widely applicable nature, and that the Dpi Customer Services team supports Help Tickets about some WAMS needs, all WAMS content has been moved to the customer service (cst) domain. The 'redirect' means that if you type in the old URL, you will be redirected to the new one.
