

# WISEdata Release Notes 3/7/23

## WISEdata Portal (WDP) Updates -

### Course Correction:

- **SCED 9 Arts Code:** A coding error was corrected surrounding the use of the “05” category code. Going forward, the “05” code will solely be associated with Arts classes on the Course list for SCED 9.

### FDS/LDS in WISEdata for 2023-24:

- **First Day of School (FDS) and Last Day of School (LDS) Displaying in WISEdata Portal:** New for the 2023-24 school year, when schools log in to WISEdata Portal, they will be able to see FDS/LDS data displayed in the Agency Contacts page. Under the “Agencies” banner, a table that currently displays:

- This table will display two additional columns: First Day of School and Last Day of School.

### L2 Updates:

A number of L2s are getting updated for the 2023-24 school year. While these L2's are being turned on this week, they will not actively be validating until WISEdata Portal flips to the new school year.

- Discipline data is now combining student behavior type and incident type for WISEdata reporting and WISEdata Portal exports. The student discipline incident association endpoint is adding 'behavior' data to it. The new endpoint will be the student discipline incident behavior association endpoint.
- This change requires Discipline updates to several L2s for the 2023-24 school year:
  - [Error 7449](#) is replacing [Error 6678](#) (“Invalid 'Discipline' and 'Behavior' combination”) for the 2023-24 school year going forward.
  - [Error 7450](#) is replacing [Error 6704](#) (“Discipline Actions endpoint is missing”) for the 2023-24 school year going forward.
  - [Error 7452](#) is replacing [Error 6663](#) (“Required field is missing, 'Behavior'”) for the 2023-24 school year going forward.
- Other L2s that are changing:
  - [Error 7464](#) is replacing [Error 6607](#) for the 2023-24 school year. The reason for the change is that starting with the 2023-24 school year, the First Day of School (FDS) and Last Day of School (LDS) will be collected from SIS vendors. This data will then push out to WISEdata and School Directory. Previously this data had to be manually entered into School Directory. Verify dates and data flow timing with your SIS vendor for accuracy.

- [Error 7466](#) covering Residency is replacing [Error 6628](#) for the 2023-24 school year going forward due to a significant change in logic and some residency data element changes in regards to the Pupil Count for Membership WiSFIP application.

## Export Updates:

- Starting with the 2023-24 school year, the Discipline Exports have been modestly changed to reflect that discipline data is now combining student behavior type and incident type.
  - The **Discipline Incident Export** contains the details of the Discipline Incidents and student *behavior* details obtained from the “Student Discipline Incident *Behavior* Association” endpoint.
- The Course Offerings Export in WISEdata Portal has added the following definitions for World Language Category and Arts Category:
  - **World Language Category:** WL courses have subgroups by language. These subgroups are used in creating Annual World Language reports by DPI.
  - **Arts Category:** Arts courses are categorized into: visual art, music, theater, and dance. Assignment to these categories is based on their NCES SCED course codes. This column helps LEAs identify which courses are included in the Art subcategories on the report card.

## WISEadmin Portal Updates

### Cyber Incident Menu Option Visible for All Roles:

- All user roles in WISEadmin Portal are now able to view the Cyber Incident menu. When items are clicked, all users can now view the incidents listed. Only the Tech Coordinator Role, however, can ‘Acknowledge’ an incident.
