WISEdata Portal Updates

Vendor Communications:

Reminder for Vendor API Integration Testing

Communications were sent out this week to remind any student information system (SIS) vendors who have not yet completed the upgrade of their systems to become compatible with the API V6 to do so quickly.

Development Work for Integrating with Assessment Vendors:

We conducted development work with assessment vendors (e.g., ACT and DRC) to improve upon the integration abilities of WISEdata Portal.

WISEdata: API Performance Improvements Continue:

Upgrade-related changes around the API v6 continue to remain in place for the 23-24 SY. This upgrade will improve performance for our users. Examples include:

- Reviewing and creating new validation messages
- Enhancing user interface
- Working out bug fixes in WISEdata Portal

SCED 10: Updates

The Courses data element page now has SCED 10 posted for the 2023-24 school year. (SCED stands for: School Courses for the Exchange of Data, created by the National Center for Education Statistics(NCES)).

CTE Courses

WISEadmin Portal and Other App Updates

WISEadmin Portal: NEW! District Library Plan

The District Library Plan is a new data collection for the 2023-24 school year. This collection is still in testing/ development mode. This data collection is only required from public schools and is based on state legislation (PI 8.01(2)(h)). District Library Plan data is entered into WISEadmin Portal. Required data elements are:

- **Date of Board Approval:** this is the date upon which the school board approves the District Library Plan.
- **Implementation Year From and Implementation Year To:** this will be a dynamic drop-down field displaying year options (current year, with a span of five years prior and six years ahead) to select from, indicating the span of the District Library Plan.
- If dates are not provided, a data Validation Error message will display.
- **District Library Media Specialist First Name, Last Name, Email:** these open text fields will allow users to enter the name and email address of the district's library media specialist.
- **District Library Plan Link:** this open text field allows users to place a hyperlink to the URL of the webpage that displays the district's Library Plan. This text must always begin with the text: https://
- If a link is not provided, a data Validation Error message will display.
- **Add or Update** button: The Add button will display when a user is entering a Library Plan for the first time. After that initial submission, users will edit their plans to match current information, and will then update their Library Plan.
- **Submission History:** this area will display a date/time stamp and name of the submitter for the date **Last Modified**, and for the person who **Submitted** that information.

Replacement KBAs

- [Error 7460](#) is replacing [Error 7154](#) due to changes in the Digital Equity Survey questions that started with the 2023-24 school year while following the same logic as Error 7154. Error 7154 is for the 2022-23 school year and prior.
- [Error 7464](#) is replacing [Error 6607](#) for the 2023-24 school year. The reason for the change is that starting with the 2023-24 school year, the First Day of School (FDS) and Last Day of School (LDS) will be collected from SIS vendors. This data will then push out to WISEdata and School Directory. Previously this data had to be manually entered into School Directory. Verify dates and data flow timing with your SIS vendor for accuracy.
