WISEdata and Ed-Fi Updates

Final Stage of Testing API v6 in WDP

DPI has conducted one final "end to end" (E2E) testing scenario to ensure the V6 API upgrade is working correctly within WISEdata Portal for the 2023-24 school year. This type of testing simulates real-world data flow from the end user's perspective. All testing passed. We are go for launch!

Displaying Last ELP Code on Student Details Screen in WDP

When you look up an individual student in WISEdata Portal (WDP), their demographic data is visible on a specific Student Detail screen. We are adding a new item to this screen, which is the last reported ELP code. This information is imported into WDP, so LEAs will not have to enter it. This ELP Code will help LEAs resolve a number of errors and warnings associated with mismatched ELP Codes.

Ed-Fi Credential: Vendor Resources Bug Fix

There was a minor issue on the Vendor Resource page of WISEdata Portal. Vendors who wanted to add resources (slide decks, videos, other documentation) for their LEAs were not able to save their changes unless they added information into the 'description' field when the 'description' field is not required. This glitch was repaired, and resources can now be added and saved without needing to add information into the 'description' field.

Fixed the student detail list in the PreACT drill-down for the Average Score Graph, so that the student's score is showing.

Added the PreACT Secure to the Cohort Trends assessment graphic. Changed the display of the Social Studies subject in the Forward Trends Dashboard, so that only 2021-2022 and 2022-2023 are displaying. This is because the standards for Social Studies changed in 2021-2022.

NEW! Warning 7473

This new warning throws when the student's school of primary enrollment submits an ELP Code of 7, and this does not align with the last submitted ELP Code. An ELP Code of 7 means that a student was never an EL student. But, if a student record has anything other than a 7 (i.e., 1-6) listed, this means the student either currently is or at some time has been an EL student. So, entering a 7 to indicate the student was 'never an EL' creates a mismatch of data.

Warning 6396

This rule was temporarily switched off for the 2023/24 SY to fix a bug. The warning was throwing when the middle name was left blank, and this is not a required field. The bug has been resolved and the rule will be turned back on again on Tuesday, August 22, 2023.
