WISEdata and Ed-Fi Updates –

WISEdata Portal: *Coming Soon!* Projects in Process

DPI is working on creating some upgrades that will simultaneously provide a more convenient and more thorough customer experience. Stay tuned for some new menu options and update buttons, likely to become available in the next two to four weeks.

WISEdata Portal: Exports

Career Education Export Update – Applied to All School Years

A “Grade Level” column will be added Career Education exports:

- Certified/Non-Certified Career Education Programs
- Other Career Education exports already have the Grade Level.

The Exports' definitions will also be updated to ensure that **all** Career Education exports include “grade level.”

Student Homeless Program Association Export Update – Applied to All Active API Years

Two new columns, Birth Date and Grade Level, are added to the Student Homeless Program Association export. This data will greatly assist with the Title 1 “End of Year Report” for ages 3-5 because users will no longer have to look up every student. It will also allow users to see grade level caseload lists.

The Exports' definitions will also be updated to ensure that the Student Homeless Program Association export includes ‘birthdate’ and ‘grade level.’

Bug Fix: “Validation Message – Special Education” 2023-24 Export File - Blank
Multiple LEAs viewed a blank report when they downloaded the special education validation messages export from WDP. The source of the bug was found and repaired. LEAs should now be able to view this export with proper data on display.

Bug Fix: Performance of Demographics Export

Some timeout errors were occurring when users attempted to download the demographics export file. Users' operating system 'wait' icon (hourglass, spinning blue circle...) would cycle, and then result in no download. The source of the bug was found and repaired. LEAs should now be able to view and download this export with proper data on display.

WiSFiP: Improvement to the Display of Membership Calculations

Improvements have been made to the 'Not Meeting Criteria' Report, which will benefit both LEAs and the DPI's Student Financial Services (SFS) Team in their review process. The improvements described below apply to all count dates.

- A number of default columns have been removed from the grid view:
 - Pupil Count Valid
 - Pupil Count Inclusion
 - Pupil Count Category
 - Pupil Count SpEd

- The calculator icon in the header of other existing columns (listed below) now offers a hover feature that allows modifications to be made on the following columns:
 - Receiving Services Column: Receiving Service denotes whether a student is enrolled and receiving services to be eligible for inclusion in the count date. Each student for whom the count date occurs on or between the entry date and the exit withdrawal date shall be identified as one of either:
 - Present - Receiving Services,
 - Absent - Receiving Services, or
 - Not Receiving Services.
 - Covers Count Date Column: A 'true/false' indicator indicating if the student is enrolled on the count date.
 - Pupil Count Resident LEA ID Column: Enter a four-digit code for the student's Resident District.
 - Pupil Count Type Column: A letter code denoting if a student is included for Pupil Count Membership:
 - F: student is primarily considered under the regular FTE proration or
 - P: special part-time FTE calculations exist
 - Pupil Count Overlap Column: Refers to multiple or overlapping enrollments:
 - If a student is enrolled in multiple LEAs on the count date, then the value displayed is "LEA."
 - If a student has multiple enrollments within a single LEA, then the value displayed is "School."

 - This mini-tutorial supports the WISEadmin User Guide because there is no actual updating of Agency Contacts within the WISEadmin Portal itself. Agency Contact information gets posted and updated in WISEdata Portal and is then pushed over to WISEadmin Portal. This is a value-added service to our users because it eliminates users completing duplicate tasks.
