<p><b>API:</b> Modified school-level access to Roster Staff Section Associations</p>	<p>We modified the Roster Staff Section Association access for educational organizations under the school level, not district level, for security. Very few schools fall under this security setup, as it primarily impacted Carmen Schools within MPS, but the system now accommodates for this situation.</p>
<p><b>WDP:</b> New L2 rule 6654</p>	<p>We implemented new L2 validation rule 6654, 'PK &amp; K3 not expected for non-Choice participants'. <p><b>WDP:</b> New pop-up alert for Queue Import &amp; Validation already running</p>	<p>Because users can manually queue validation in the portal, we wanted to alert users who tried to manually trigger validation when validation was already running. We implemented a new pop-up to indicate to a user trying to queue validation when it's already running: "Action cannot be performed at this time. Validation for this Agency is already queued or running."</p>
