ESEA Law

2

- ESEA requires LEAs receiving Title I and/or Title II to provide equitable services to students and educational personnel in private schools.
- Services are determined after meaningful consultation with all private schools in the area.
- Services must be: secular; neutral; and non-ideological.

Annual Consultation

3

Contact **ALL** private schools within the boundaries of the school district to:

- Determine participation and
- Invite for consultation

LEAs must maintain copies of the invitation for consultation along with the agenda for the consultation meeting.

Annual Consultation

Discuss the following:

- Evaluation of services provided in current year
- Allocations for services
- Services to be provided in new year (how, when, where, and by whom)
 - Must be based on the private school's needs assessment
- Evaluation of services provided in upcoming year

In addition, for Title I, discuss the following:

- Measures used to determine eligible students;
- Progress monitoring of students;
- Exit criteria for Title I programming; and
- Parent involvement activities.

LEAs must maintain written documentation of the consultation process and decisions made.

Annual Consultation

5

Collect the following data:

- Student enrollment
- The Private School Participation Verification form (PI-9550-AC) for each private school in the district.
 - The form is found in the ESEA Consolidated Online Application.
 - Upload the form to the Application after it is reviewed and signed.

In addition, for Title I, collect the following:

- Low-income private school students data
- Public school attendance areas, grade spans of private school students

Determining Private School Students Eligible for Title I Services

11

Private school student eligibility for TI service is determined by:

- Educational need
 - In consultation with the private school, the district must establish multiple, educationally related, objective criteria to determine which private school children are most at risk of failing state academic standards in mathematics and/or reading.

AND

- Residence
 - Private school students must live in a Title I receiving public school attendance area.

Winkler and Cooper Elementary are the only two Title I schools in the district, the rest of the public schools are not. There are five low income students attending Cornerstone Academy that generate the allocation but all 34 students living in the Winkler and Cooper Elementary attendance areas are eligible for Title I services.

Determine Title I Programming

13

- Rank eligible private school students.
 - Private school students' academic levels are not compared to those of public school students.
- Review the per-pupil amounts of the private school students' public school attendance areas of residence.
- Serve the private school as a targeted assistance program – based on the core academic needs of the Title I students.

Title I Services to Private School Children

14

- Begin services in the private school at the same time as in the public school.
- Supplemental Instruction by Highly Qualified Teachers
 - Academic, research-based, *supplemental* programs that help students improve their academic achievement in the regular private school classroom (i.e., reading and math).
 - Services must be equitable to the public school but not necessarily identical.
- Examples:
 - Pull-out small group instruction;
 - Extended day services; and
 - Summer school programs.

Title I Services to Private School Children

15

- Assessment of Student Progress
 - Use assessments comparable to the public school;
 - Ensure alignment to the definition of "annual progress" determined during the consultation process; and
 - Review exit criteria and results.
- Location of Title I Services
 - Services can occur at the private school or at the public school.
 - It is the public school district's responsibility to find space for these services.

Title I Services to Private School Parents

16

- Parent Involvement
 - An LEA must provide equitable services to parents of Title I private school participants in accordance with Section 1118 of the Title I statute.
 - ✦ Parent notification, parent meetings, etc.
- Examples:
 - Private school parents of Title I students participate in the public Title I school(s) parent involvement activities.
 - Private school hosts parent involvement activities specific for parents of Title I students.
 - Title I teachers communicate with parents on students' academic progress.

Title I Services to Private School Staff

17

- **Professional Development**

- Private school teachers working directly with Title I students may participate.
- Must be related to increasing academic achievement of Title I students.
- Must be aligned to the private school's needs assessment and focused on increasing Title I students' achievement.
- Must be on-going and secular.

LEA's evaluation of professional development activities should include the review of participants' assessment scores and impact on student achievement.

- **Examples:**

- Attend the LEA's professional development offerings.
- Attend conferences related to increasing academic achievement of Title I students.
- Participate in book studies.

Private School Services Under Title II

20

Private school services for TII are determined by:

- **Educational need**

- In consultation with the private school, the district must evaluate the needs of the school in core academic areas.
- Needs assessment should address student achievement and teacher needs based on research-based criteria (i.e., classroom observation, surveys, recommendations)

Title II Services to Private School Staff

21

- Professional Development
 - Aligned to the needs assessment
 - Evaluated using research-based models
 - Related core academic areas only
 - Available to all private school educators including teachers and administrators
 - Ongoing and secular

Title II Services to Private School Staff

22

- Examples:
 - Attend the LEA's professional development offerings.
 - Attend conferences related to core academic areas.
 - Tuition reimbursement for graduate or undergraduate coursework.
 - Provide stipends to teachers and administrators who participated in core academic areas.

Title II Services to Private School Staff

23

Core academic area:

- Arts, music, dance, drama/theater
- Civics and government, history, geography, and economics
- Foreign languages
- Reading and English language Arts
- Mathematics
- Science: life science, physical science, earth and space science, astronomy, chemistry, and physics

Title II Services to Private School Staff

24

Non-Core academic areas:

- Agriculture
- Bookkeeping, accounting, business, cooperative education, and library science
- Health education, health occupations, and physical education
- Family and consumer sciences, technology education, marketing education, trades and industry, computer science, driver education, and journalism
- Psychology, sociology, and speech
